**SUBJECT:**

Acceptance of Awards Totaling \$58,476,728 from the Bureau of Land Management for the Implementation of Three Projects: (1) Children's Science and Nature Park (CIP Project No. 10645); (2) Northern Beltway Trail Phase II (CIP Project No. 10592), and (3) Craig Ranch Regional Park 20-Acre Expansion (CIP Project No. 10617) Funded by the Southern Nevada Public Land Management Act Funds, Round 19; Approval of Designated Cost Sharing/Matching Funds in the Total Amount of \$1,128,351 for the Three Projects; and Authorization for City Manager or her Designee to Execute Appropriate Related Agreements in an Amount Not to Exceed the Total Project Budgets of \$59,605,079. (Ward 2 - Garcia-Anderson, Ward 3 - Black, Ward 4 - Cherchio) (For Possible Action; Recommendation - Accept, Approve, and Authorize)

Accept Award from the Bureau of Land Management, approve cost sharing/matching funds, and authorize the City Manager or her Designee to act as stated.

**STAFF COMMENTS AND BACKGROUND INFORMATION:**

The Bureau of Land Management (BLM) awarded \$58,476,728 of Round 19 Southern Nevada Public Land Management Act funds to the City of North Las Vegas for the administration, design, and construction of three projects: (1) Children's Science and Nature Park (CIP 10645); (2) Northern Beltway Trail Phase II (CIP10592), and (3) Craig Ranch Regional Park 20-Acre Expansion (CIP 10617). The BLM awarded the following amounts to each project:

- Children's Science and Nature Park: \$31,779,248, with \$376,117 in cost sharing/matching funds;

- Northern Beltway Trail Phase II: \$2,072,495, with \$376,117 in cost sharing/matching funds;
- Craig Ranch Regional Park 20-Acre Expansion: \$24,624,985, with \$376,117 in cost sharing/matching funds

The total amount of cost sharing/matching funds the City is responsible for is \$1,128,351. The total amount budgeted under all three projects is \$59,605,079.

Staff recommends that City Council approve acceptance of the awarded funds for the above-referenced projects and approve the use of \$1,128,351 in cost sharing/matching funds. Staff further recommends that the City Council authorize the City Manager or her designee to execute related agreements for the projects, including in accordance with NRS 338, to ensure their timely completion under the applicable governing construction timelines, and for the general benefits to City residents from the completion of these projects.
