First Amendment to Elgin Sweeper Parts, Vactor Parts, and Additional Parts and Supplies Purchase Agreement with HAAKER Equipment Company to Increase the Total Not to Exceed Amount from \$305,255 to \$610,510 for a Term of Five Years (Three-Year Term and Two One-Year Renewal Options) and Authorization for the City Manager or Her Designee to Exercise Renewal Options. **EXPLANATION:** This amount is approved in the annual Fleet Operations' Service and Supplies budget for Garage Auto and Other Service expenditures.

**STAFF COMMENTS AND BACKGROUND INFORMATION:**

This First Amendment to Parts and Supplies Purchase Agreement with HAAKER Equipment Company increases the total not to exceed amount of the Agreement from \$50,000 to \$100,000 for the first fiscal year, with a 10% escalation rate increase per year, for a three-year term with the option to renew for an additional two, one-year periods.

An increase in the total not to exceed amount of the Agreement is necessary due to an increased need for parts and preventative maintenance and repair services to repair and maintain aging vehicles within the fleet not earmarked for replacement at this time.

HAAKER Equipment Company provides specific parts and services for Vactor, Sweeper and Camera Trucks within the City's Fleet and is the sole source provider of Elgin and Vactor parts. Fleet Operations establishes a

budget for such products and services each fiscal year. The funding utilized in this Agreement has already been set aside, and recent spending patterns over multiple years support these costs.
