**STAFF COMMENTS AND BACKGROUND INFORMATION:**

The City of North Las Vegas is committed to building a charter school authorization program that meets the needs of its educational landscape. To facilitate this initiative, Lumen Impact Group dba LUMEN will assist with the packaging and rollout of the program. Its expertise in charter school authorization processes will ensure regulatory compliance, effective operational planning, and stakeholder engagement.

The original service agreement covered a three-month period between September 1, 2024 and November 30, 2024, with a total contract value not to exceed \$9,375.00. The First Amendment covers the period from December 1, 2024 through August 31, 2025, with an option to extend the term for up to one additional year and provides for an increase in cost in an amount not to exceed \$65,625.00. During the Term, LUMEN will deliver a range of services, including:

**1. Regulatory Compliance:**

- Ensure compliance with state and federal charter school regulations.
  - Assist in the development of city-specific policies for charter school authorization program.
- **Operational Planning:**
  - Create detailed timelines and strategies for the implementation of the authorization process.
  - Offer advisory support throughout the rollout phase.
- **Ongoing Support:**
  - Provide continuous advisory services over the course of the Agreement to ensure the program's sustainability and success.

LUMEN was selected due to its expertise and professional qualifications in charter school authorization. Its experience will allow the City to implement a comprehensive, compliant, and successful charter school authorization program. LUMEN has a proven track record in educational consultancy and was chosen to ensure the city's charter school program is efficiently rolled out.
