The Public Utilities Commission of Nevada ("Commission") hereby grants, pursuant to the Commission's Order dated May 11, 2022, Central Telephone Company d/b/a CenturyLink the authority to change its name to CenturyLink of Nevada, LLC d/b/a CenturyLink and to continue to operate as a competitive supplier of telecommunication service within the state of Nevada and as a provider of last resort for portions of Nevada.

CenturyLink of Nevada, LLC d/b/a CenturyLink has been granted authority to operate as a competitive supplier of telecommunication service within the State of Nevada and has been designated by the regulations of the Commission as a provider of last resort for basic network service and business line service for the service area as described in maps and legal descriptions which are on file with, and have been approved by, the Commission. These maps and legal descriptions are attached hereto as attachment A.


CenturyLink of Nevada, LLC d/b/a CenturyLink is hereby granted this Certificate of Public Convenience and Necessity as evidence of its authority to operate as a competitive supplier of telecommunication service within the state of Nevada and as a provider of last resort for basic network service and business line service within its service area, subject to all applicable provisions of the Nevada Revised Statutes; all applicable rules, regulations and orders of the Commission; and such terms, conditions and limitations as are now or may hereafter be attached to the exercise of the privileges granted to the utility.

This Certificate of Public Convenience and Necessity supersedes and replaces, in all respects, CPC 687 Sub 14. CPC 687 Sub 14 is hereby cancelled.

As a condition of this Certificate, CenturyLink of Nevada, LLC d/b/a CenturyLink shall render reasonably continuous and adequate service to the public within its service area and in pursuance of the authority granted. Nothing contained herein shall be construed to create a franchise or to constitute the grant of an irrevocable Certificate. Failure to comply with all applicable provisions of the Nevada Revised Statutes; all applicable rules, regulations and orders of the Commission; and any applicable terms, conditions and limitations attached to the granted privileges shall comprise sufficient grounds for the suspension or revocation of this Certificate.


This Certificate of Public Convenience and Necessity shall not be conveyed or transferred without the Commission's prior approval.

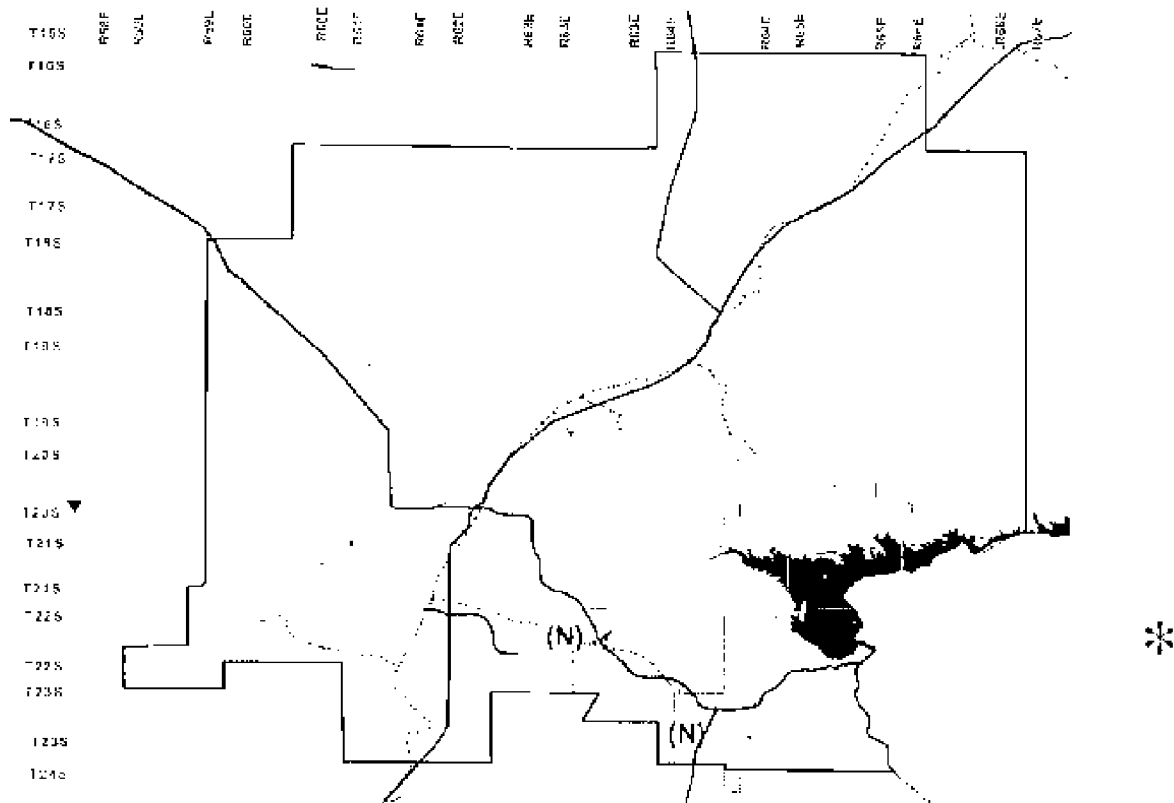

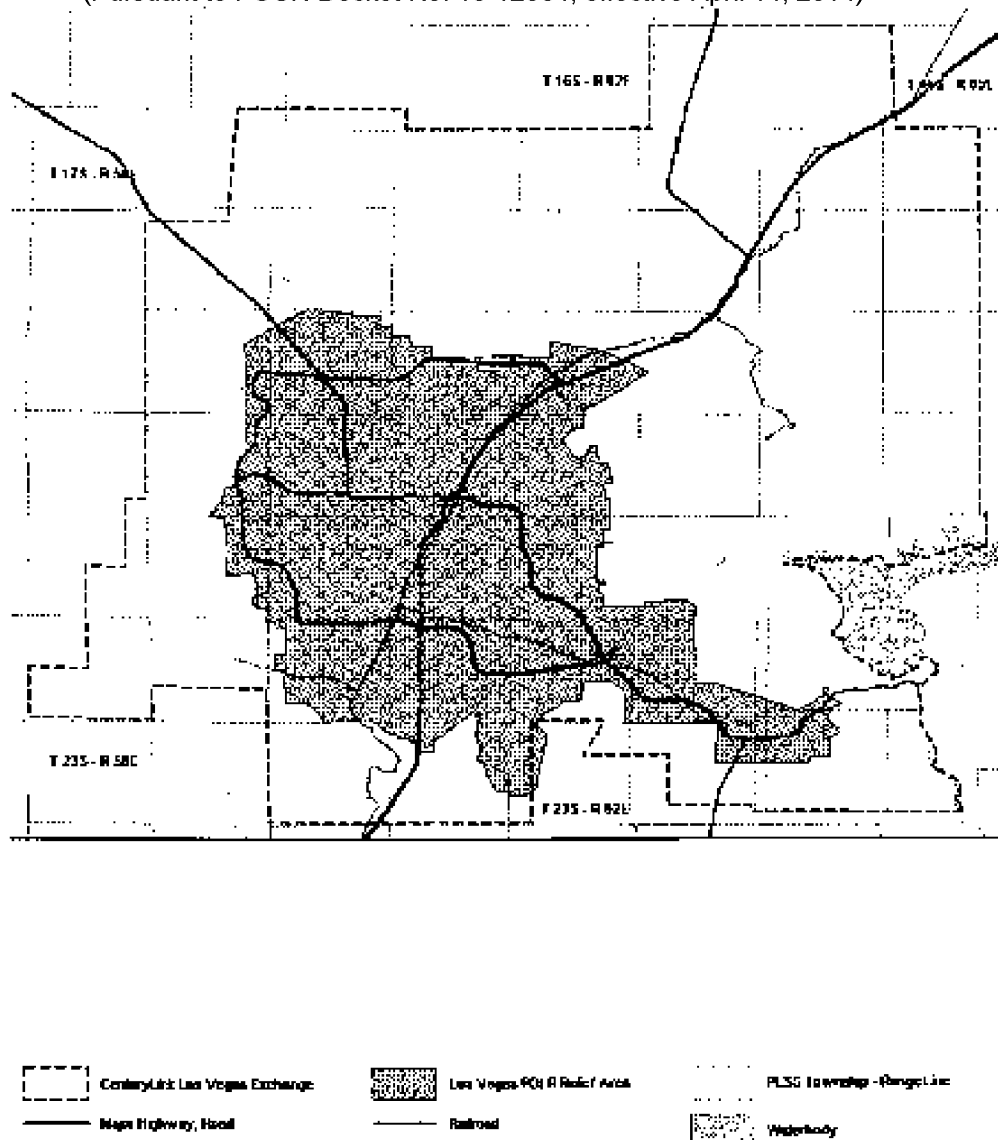

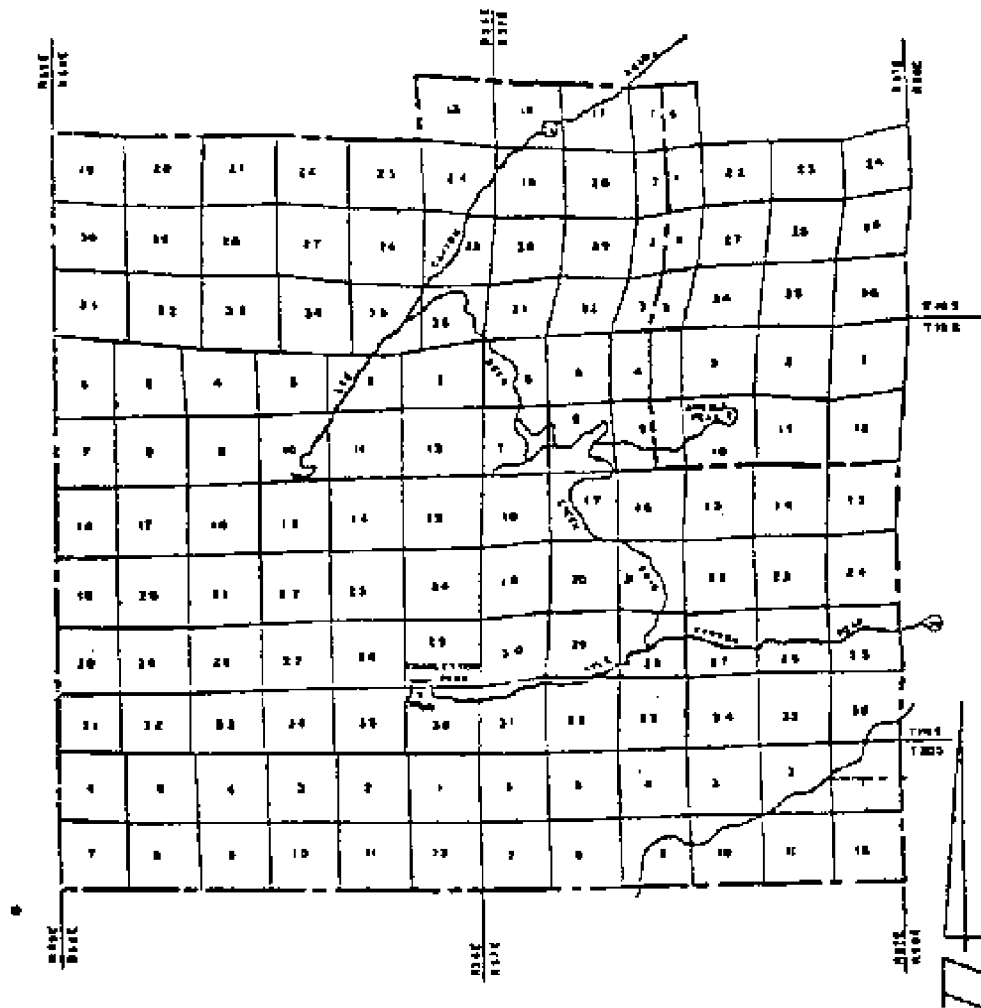

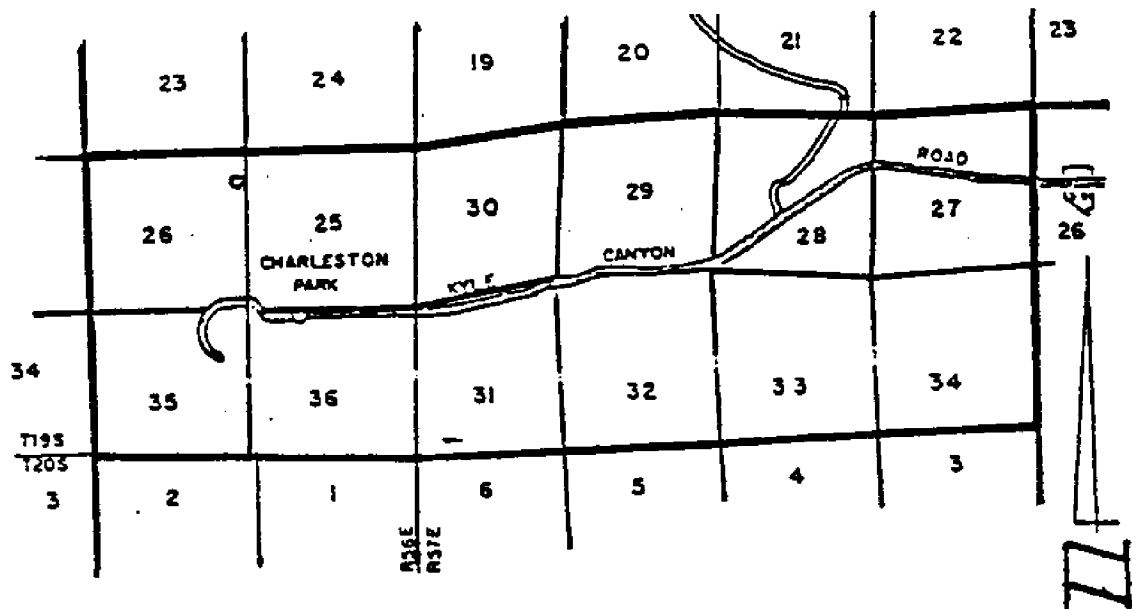

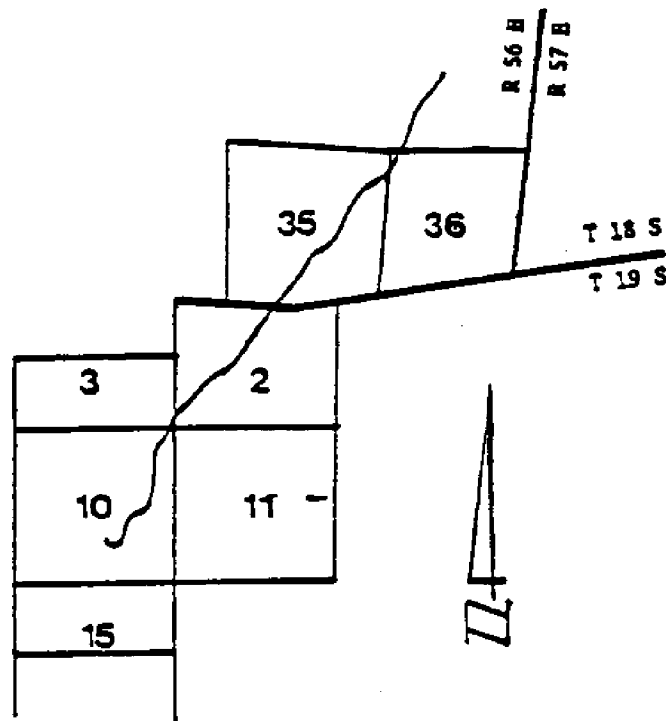

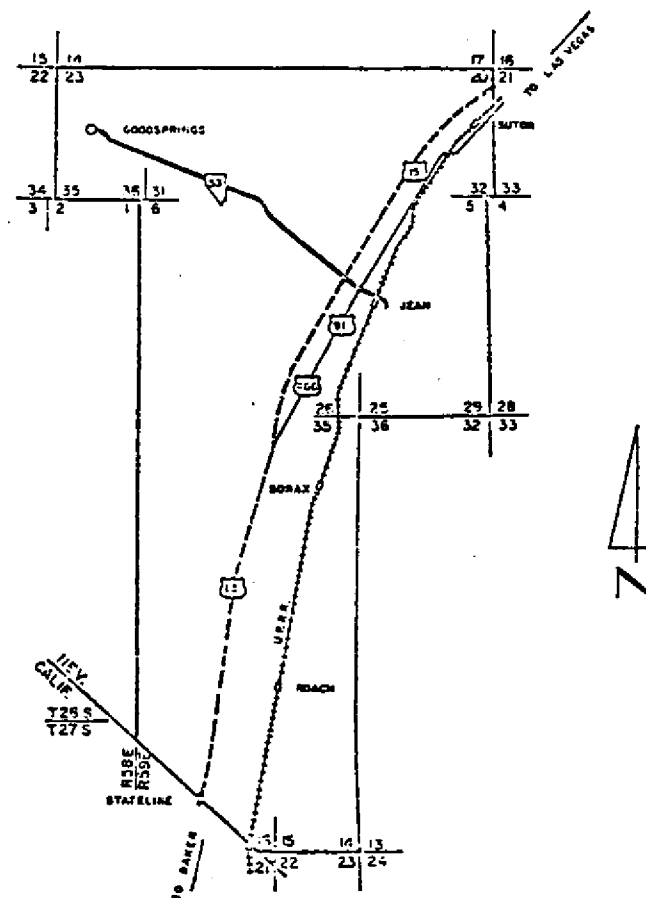

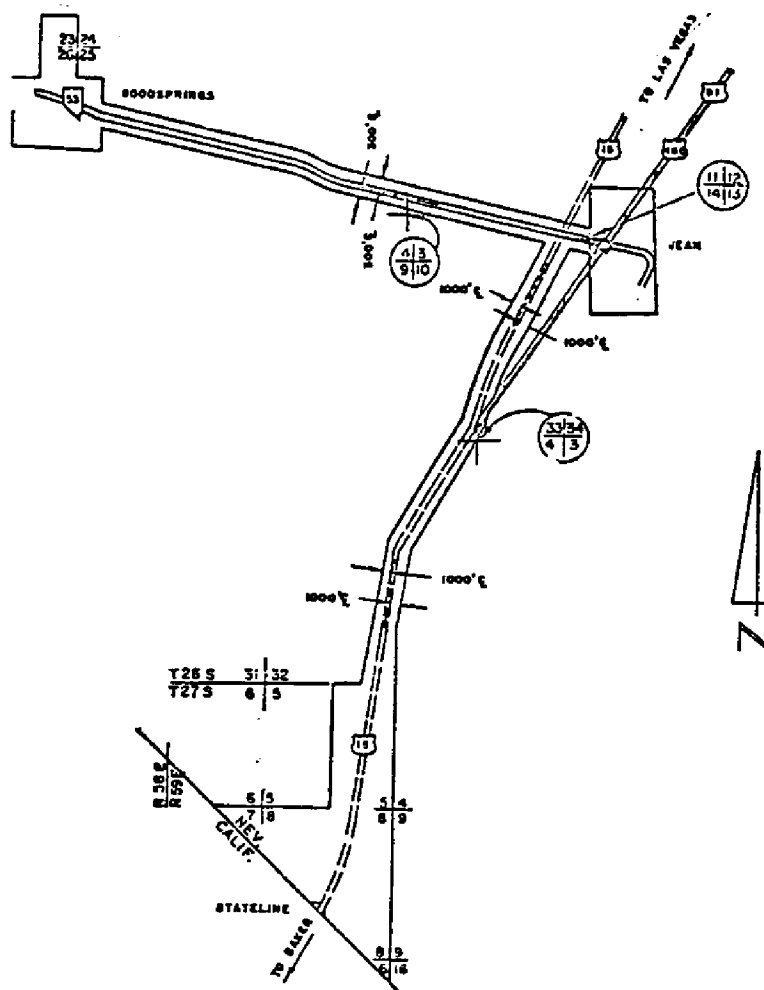

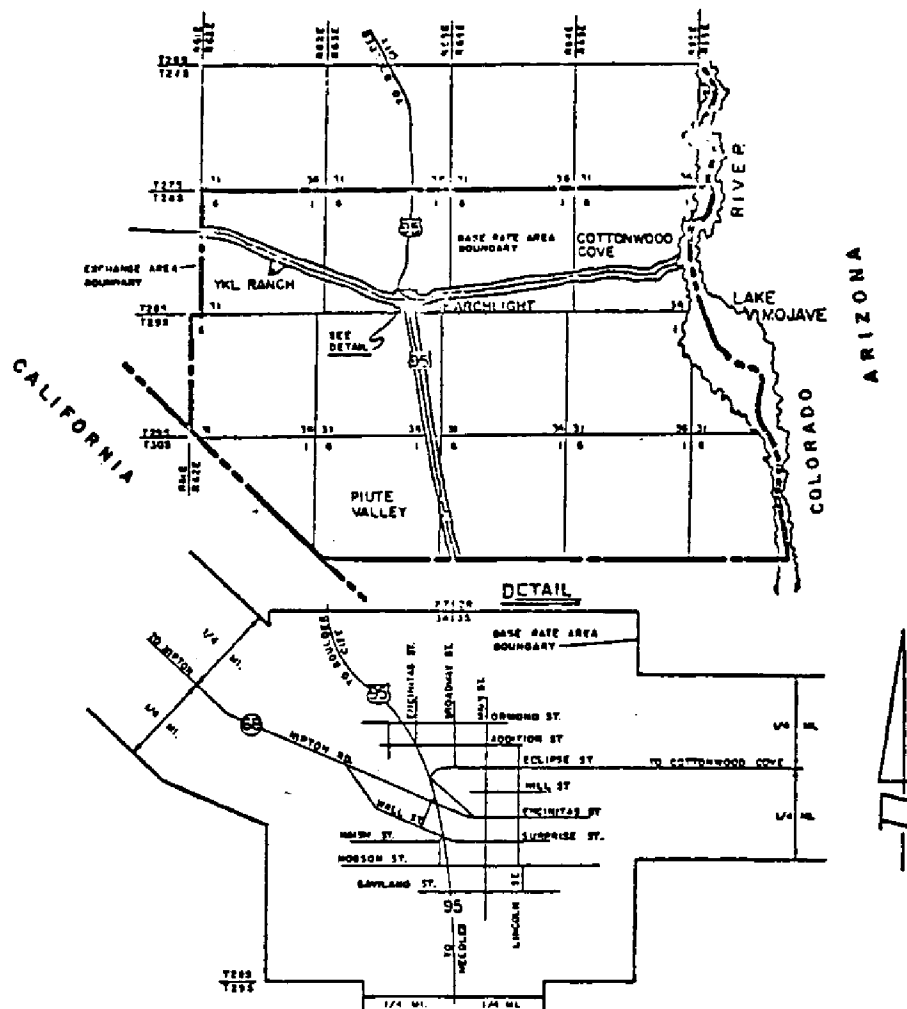

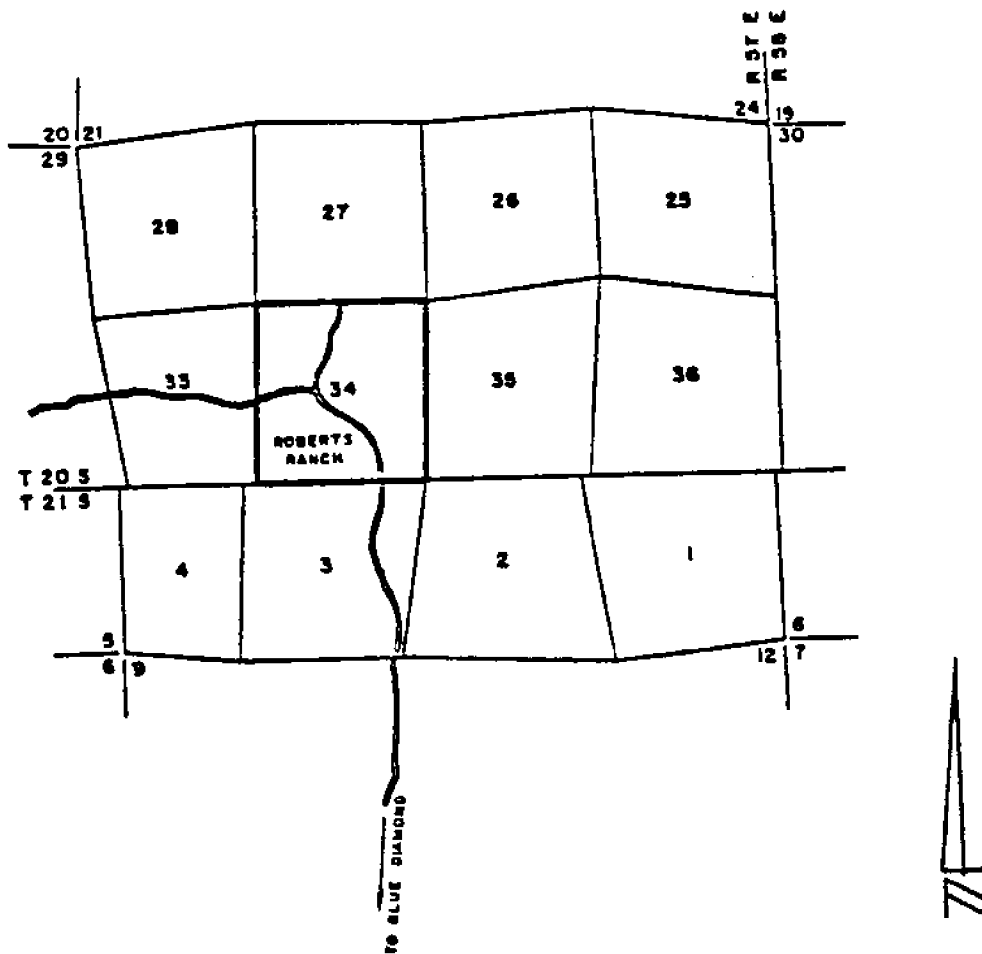

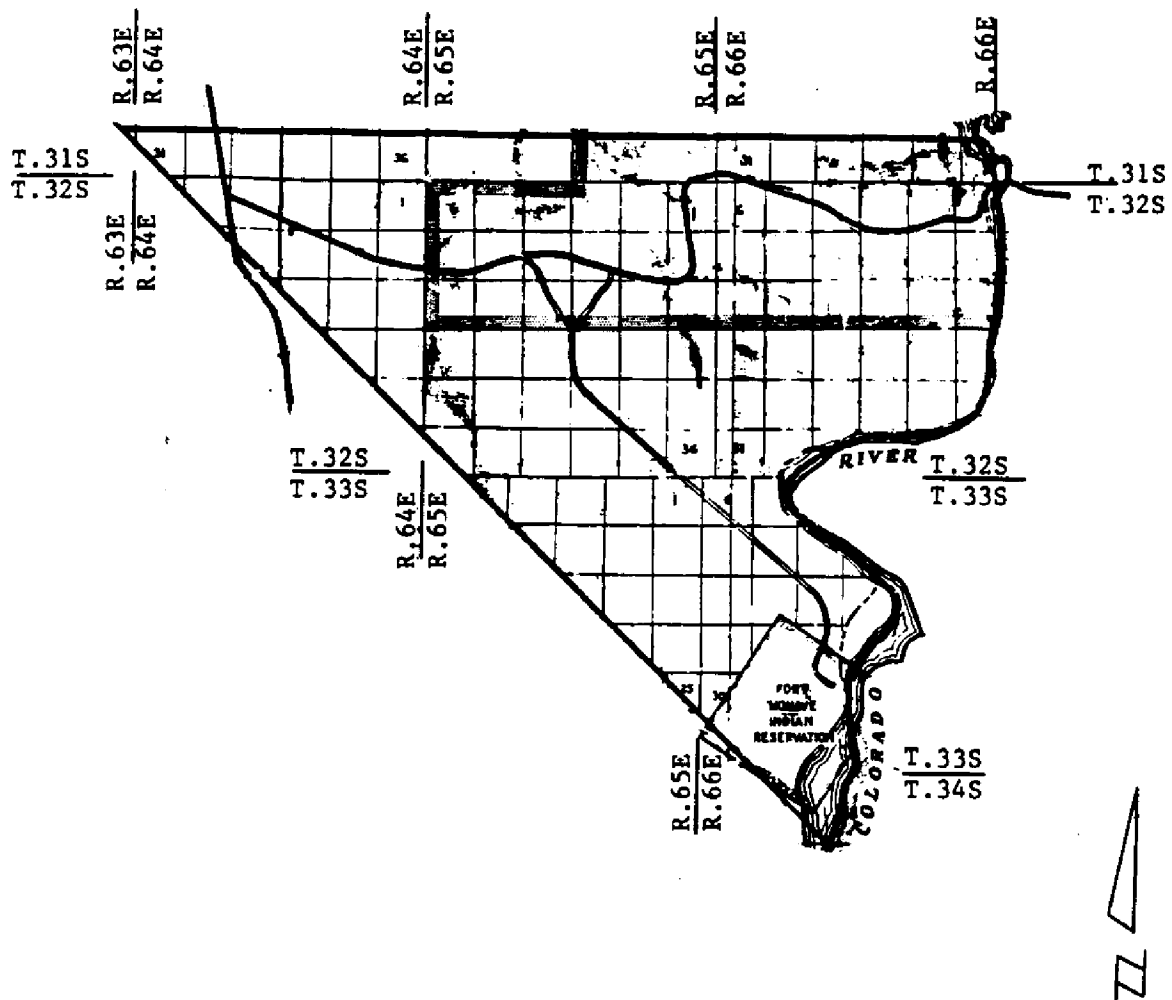

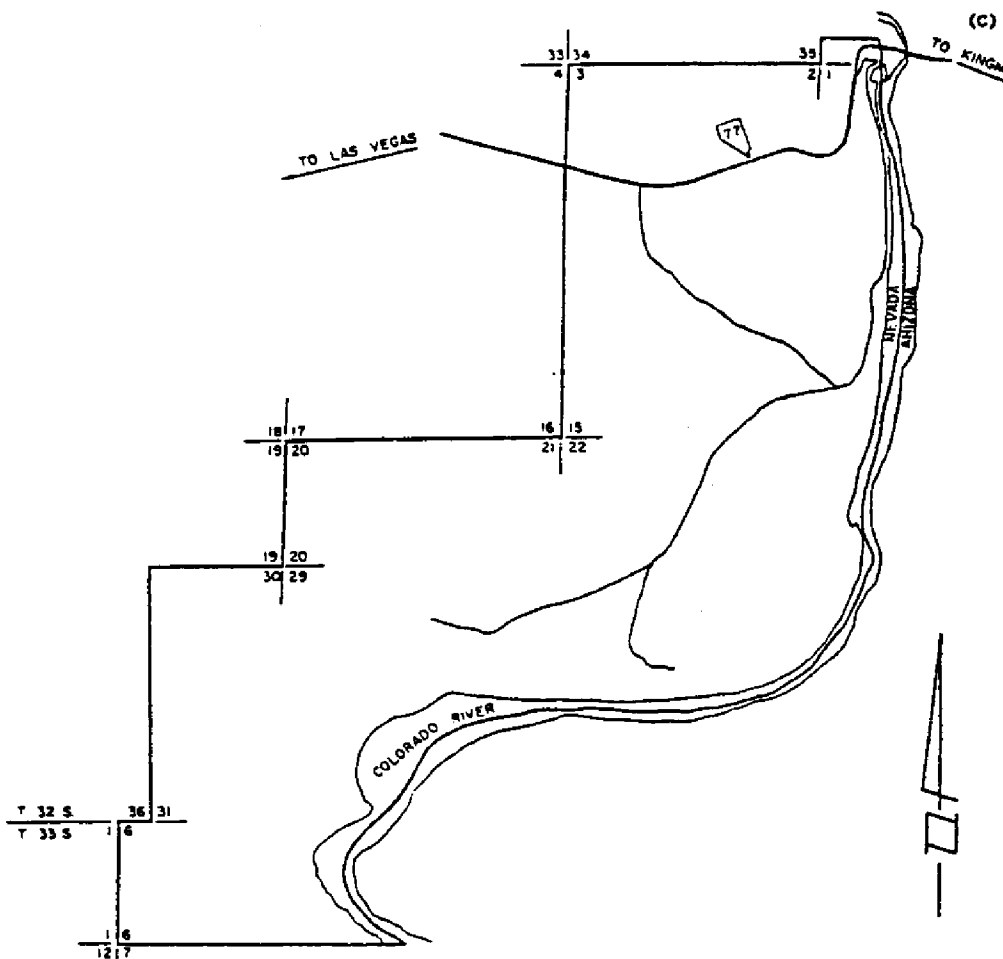

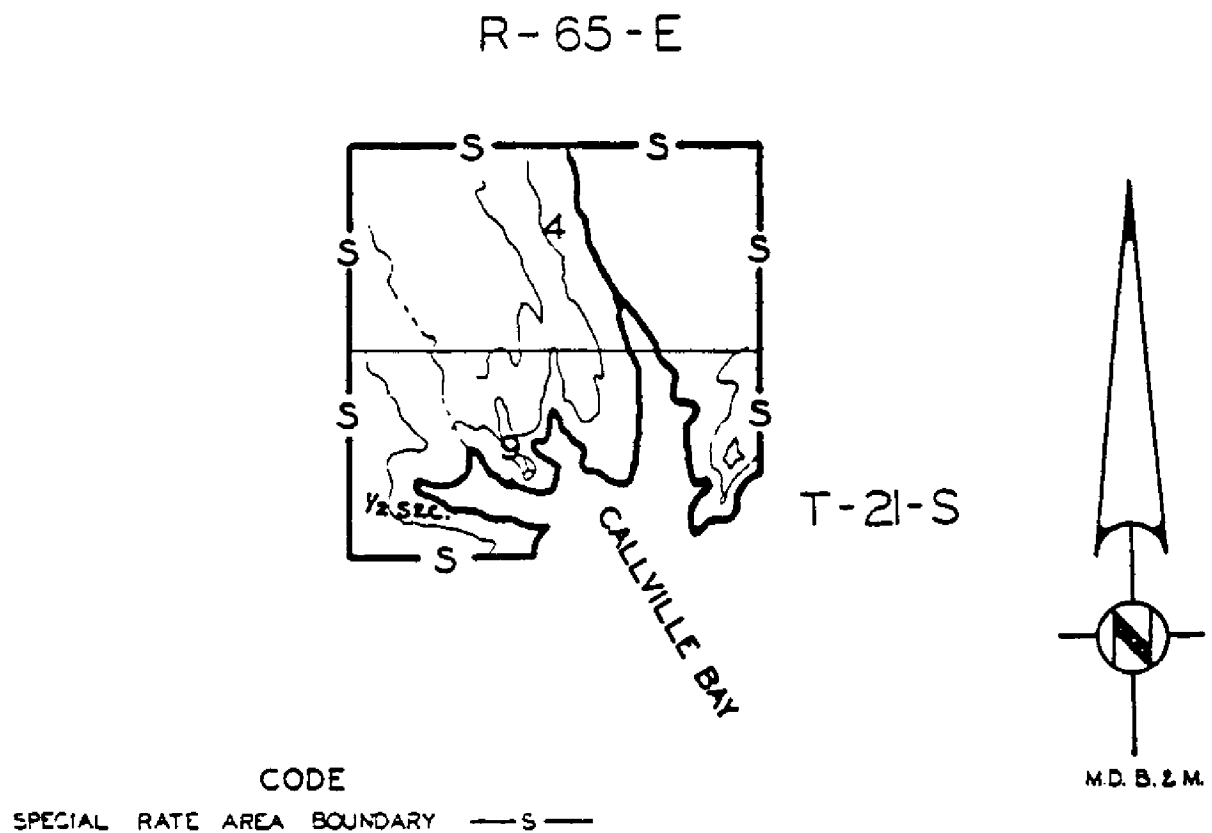

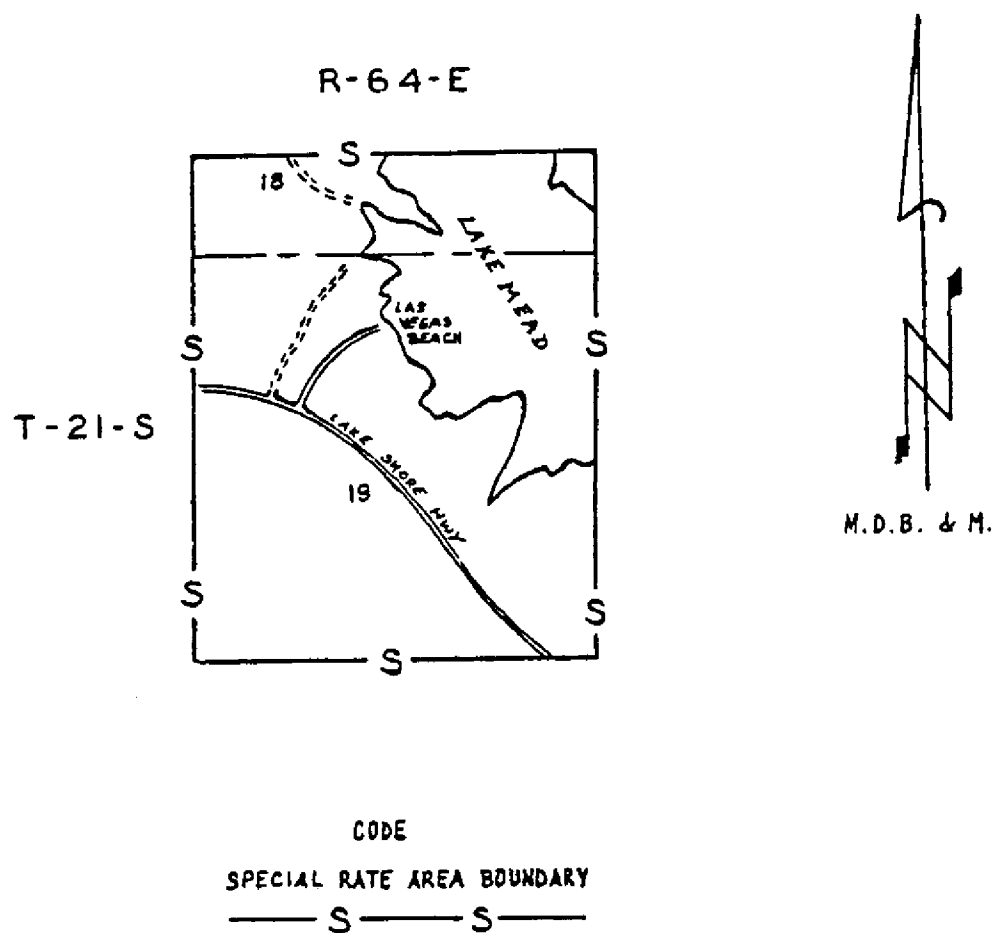

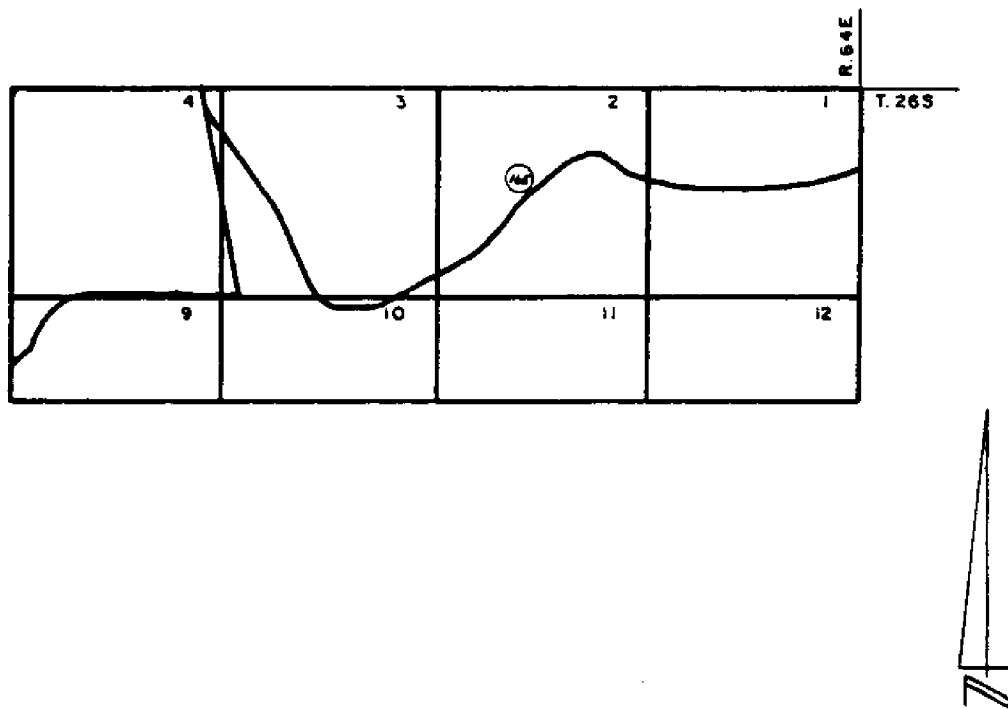
