STAFF COMMENTS AND BACKGROUND INFORMATION:

The Acquisition, Rehabilitation, and Rental (ARR) Program is a historical North Las Vegas program that was started and approved in 2009 with available, non-recurring grant funds. The ARR program has since been updated and utilized in the City, as needed.

With the recent identification of the great need of affordable housing in southern Nevada, the City has found it beneficial once again to fund this program with available Community Development Block Grant funding. Program guidelines have been updated and applications for new providers of the ARR program have been completed. Two applicants submitted requests for funding affordable housing developments through this program application. An internal City of North Las Vegas application review team was assembled to review the application and the review team has provided the attached recommendations for funding under the ARR program.
