EXPLANATION: THIS DESCRIPTION REPRESENTS THE VACATION OF A PORTION OF A PUBLIC UTILITY EASEMENT IN SUPPORT OF THE "VTS VILLAGE 1 PARCEL 1.20" PROJECT.

DESCRIPTION

THAT PORTION OF A PUBLIC UTILITY EASEMENT GRANTED PER A DOCUMENT RECORDED APRIL 10, 2023, IN BOOK 20230410 OF OFFICIAL RECORDS, AS INSTRUMENT NO. 00761, LYING WITHIN THE NORTHWEST QUARTER (NW1/4) OF SECTION 15, TOWNSHIP 19 SOUTH, RANGE 61 EAST, M.D.M., CITY OF NORTH LAS VEGAS, CLARK COUNTY, NEVADA, DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHWEST CORNER OF SAID SECTION 15;

THENCE ALONG THE NORTHERLY LINE OF THE NORTHWEST QUARTER (NW1/4) OF SAID SECTION 15, SOUTH 88°42'28" EAST, 1372.37 FEET;

THENCE DEPARTING THE NORTHERLY LINE OF THE NORTHWEST QUARTER (NW1/4) OF SAID SECTION 15, SOUTH 01°17'32" WEST, 2036.69 FEET TO THE **POINT OF BEGINNING**;

THENCE SOUTH 22°25'04" WEST, 13.67 FEET;

THENCE FROM A POINT TO WHICH A RADIAL LINE BEARS NORTH 18°51'39" WEST, CURVING TO THE LEFT ALONG AN ARC HAVING A RADIUS OF 45.50 FEET, CONCAVE SOUTHEASTERLY, THROUGH A CENTRAL ANGLE OF 47°51'24", AN ARC LENGTH OF 38.00 FEET TO A POINT TO WHICH A RADIAL LINE BEARS NORTH 66°43'04" WEST;

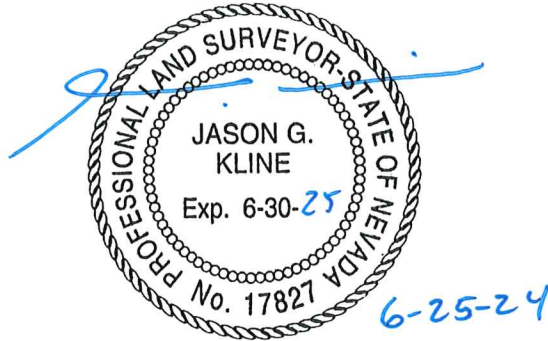
THENCE FROM A POINT TO WHICH A RADIAL LINE BEARS NORTH 82°29'18" WEST, CURVING TO THE RIGHT ALONG AN ARC HAVING A RADIUS OF 45.50 FEET, CONCAVE SOUTHEASTERLY, THROUGH A CENTRAL ANGLE OF 66°08'13", AN ARC LENGTH OF 52.52 FEET TO THE **POINT OF BEGINNING**.

CONTAINING 257 SQUARE FEET, MORE OR LESS.

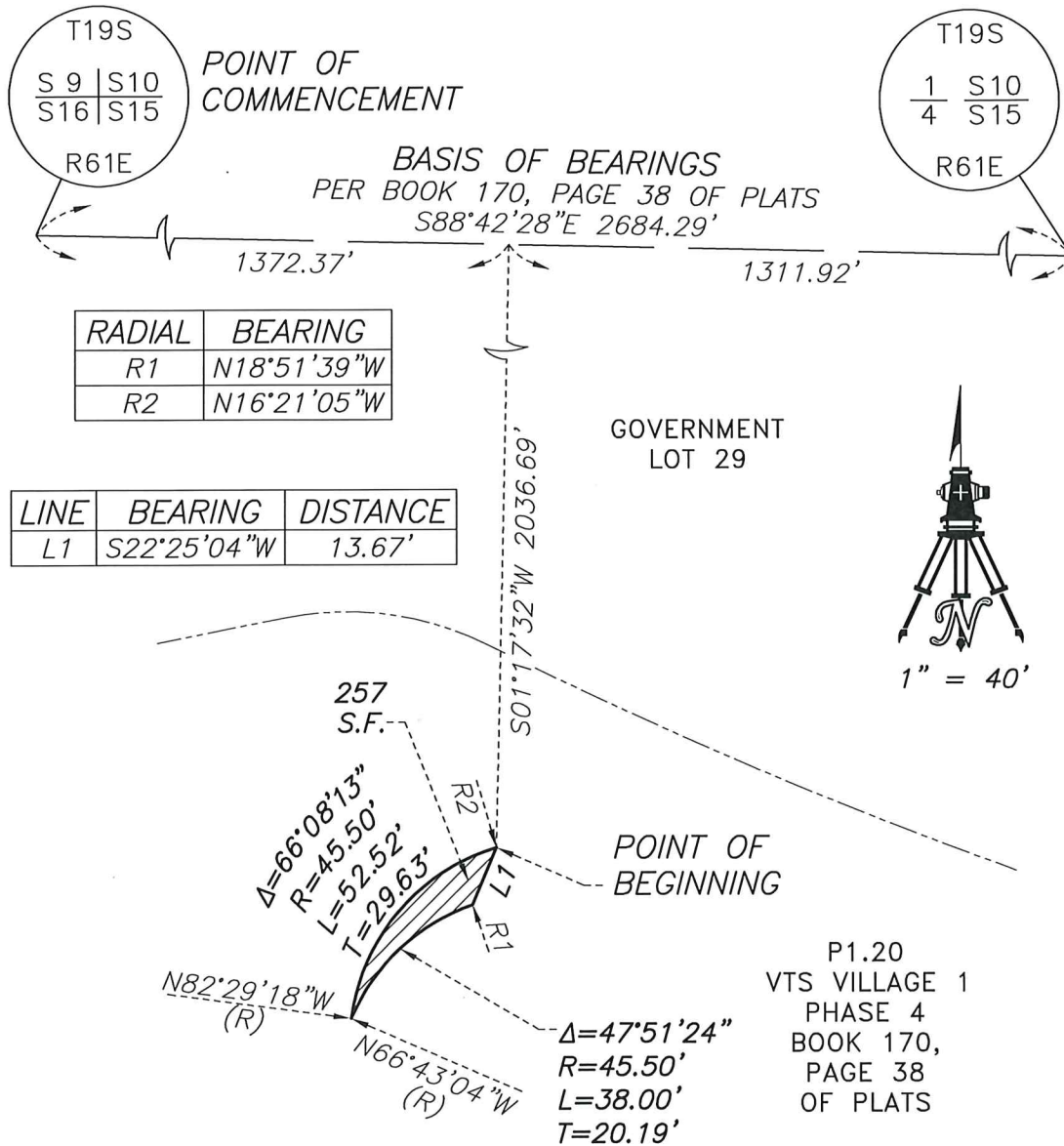
