EXPLANATION

Vacation of a 15.00-foot by 15.00-foot Public Utility Easement, being a portion of the Northeast Quarter (NE 1/4) of Section 29, Township 19 South, Range 62 East, M.D.B. & M., Clark County, Nevada, more particularly described as Parcel A of Parcel Map File 130, Page 13, recorded at Book 20231221, Instrument Number 3302.

LEGAL DESCRIPTION

COMMENCING at the Northeast corner of the Northeast Quarter (NE 1/4) of said Section 29;

Thence South 89°02'07" West 122.58 feet along the North line of said Northeast Quarter (NE 1/4);

Thence departing said North line, South 00°57'53" East 50.00 feet to the South Right of Way line of North Belt Road, said point also being the POINT OF BEGINNING;

Thence North 89°02'07" East 15.00 feet along said North Right of Way line;

Thence departing said North Right of Way line, South 00°57'53" East 15.00 feet;

Thence South 89°02'07" West 15.00 feet;

Thence North 00°57'53" West 15.00 feet to the POINT OF BEGINNING.

Containing 225 square feet, more or less.

BASIS OF BEARINGS

Basis of Bearings referenced herein is North 89°02'07" East being the Bearing of the North line of the Northeast Quarter (NE 1/4) of the Northeast Quarter (NE 1/4) of Section 29, Township 19 South, Range 62 East, M.D.B. & M., North Las Vegas, Nevada, as shown on that certain Parcel Map recorded at File 130, Page 13 at the office of the Recorder, Clark County, Nevada.


