STAFF COMMENTS AND BACKGROUND INFORMATION:
On October 10, 2022, the City and Core & Main, LP, entered into an Agreement to Use Local Government Contract for Plumbing Supplies – Materials Only for various maintenance, repair, and service supplies on an as-needed basis for pump stations, underground piping, water, and sewer connections. Pursuant to the terms of the agreement, the City exercised its first one-year renewal option on April 4, 2023. This First Amendment increases the total not-to-exceed amount from \$465,000.00 to \$1,573,000.00; \$483,000 for the first renewal option and \$825,000 for the second renewal option, and exercises the second option to renew the agreement for an additional one-year term from July 1, 2024 to June 30, 2025.
