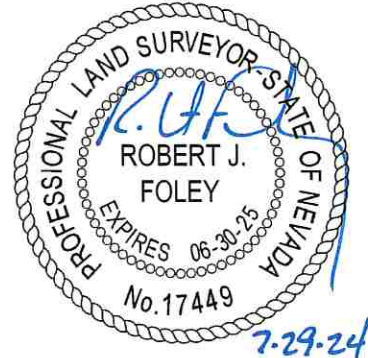

EXPLANATION

THIS LEGAL DESCRIPTION DESCRIBES A PARCEL OF LAND GENERALLY LOCATED SOUTH OF TROPICAL PARKWAY AND WEST OF N. LAMB BOULEVARD FOR PUBLIC RIGHT-OF-WAY VACATION PURPOSES.

LEGAL DESCRIPTION

A PORTION OF TROPICAL PARKWAY DEDICATED TO CITY OF NORTH LAS VEGAS BY A PARCEL MAP RECORDED MAY 20, 2004 IN FILE 107, PAGE 38 OF PARCEL MAPS CLARK COUNTY OFFICIAL RECORDS. SITUATE IN THE SOUTHEAST QUARTER (SE 1/4) OF SECTION 30, TOWNSHIP 19 SOUTH, RANGE 62 EAST, M.D.M., CITY OF NORTH LAS VEGAS, CLARK COUNTY, NEVADA DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER OF SAID SOUTHEAST QUARTER (SE 1/4) OF SECTION 30; THENCE SOUTH 89°05'00" WEST ALONG THE NORTH LINE OF SAID SOUTHEAST QUARTER (SE 1/4) A DISTANCE OF 166.34 FEET; THENCE DEPARTING SAID NORTH LINE SOUTH 00°55'00" EAST, 50.00 FEET TO THE **POINT OF BEGINNING**;

THENCE SOUTH 00°55'00" EAST, 15.00 FEET TO THE SOUTH RIGHT-OF-WAY LINE OF SAID TROPICAL PARKWAY; THENCE ALONG SAID SOUTH RIGHT-OF-WAY LINE THE FOLLOWING FIVE (5) COURSES: (1) SOUTH 89°05'00" WEST, 93.39 FEET TO THE BEGINNING OF A TANGENT CURVE CONCAVE NORTHEASTERLY HAVING A RADIUS OF 105.00 FEET; (2) NORTHWESTERLY ALONG THE ARC OF SAID CURVE 33.34 FEET THROUGH A CENTRAL ANGLE OF 18°11'42" TO THE BEGINNING OF A REVERSE CURVE CONCAVE SOUTHWESTERLY HAVING A RADIUS OF 95.00 FEET TO WHICH A RADIAL LINE BEARS NORTH 17°16'42" EAST; (3) NORTHEASTERLY ALONG THE ARC OF SAID CURVE 30.17 FEET THROUGH A CENTRAL ANGLE OF 18°11'42"; (4) SOUTH 89°05'00" WEST, 57.81 FEET; (5) NORTH 89°38'37" WEST, 225.06 FEET; THENCE DEPARTING SAID SOUTH RIGHT-OF-WAY LINE NORTH 89°05'00" EAST, 438.66 FEET TO THE **POINT OF BEGINNING** AS SHOWN ON EXHIBIT B ATTACHED HERETO AND MADE A PART HEREOF.

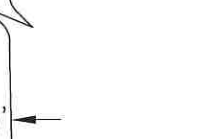
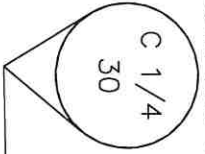

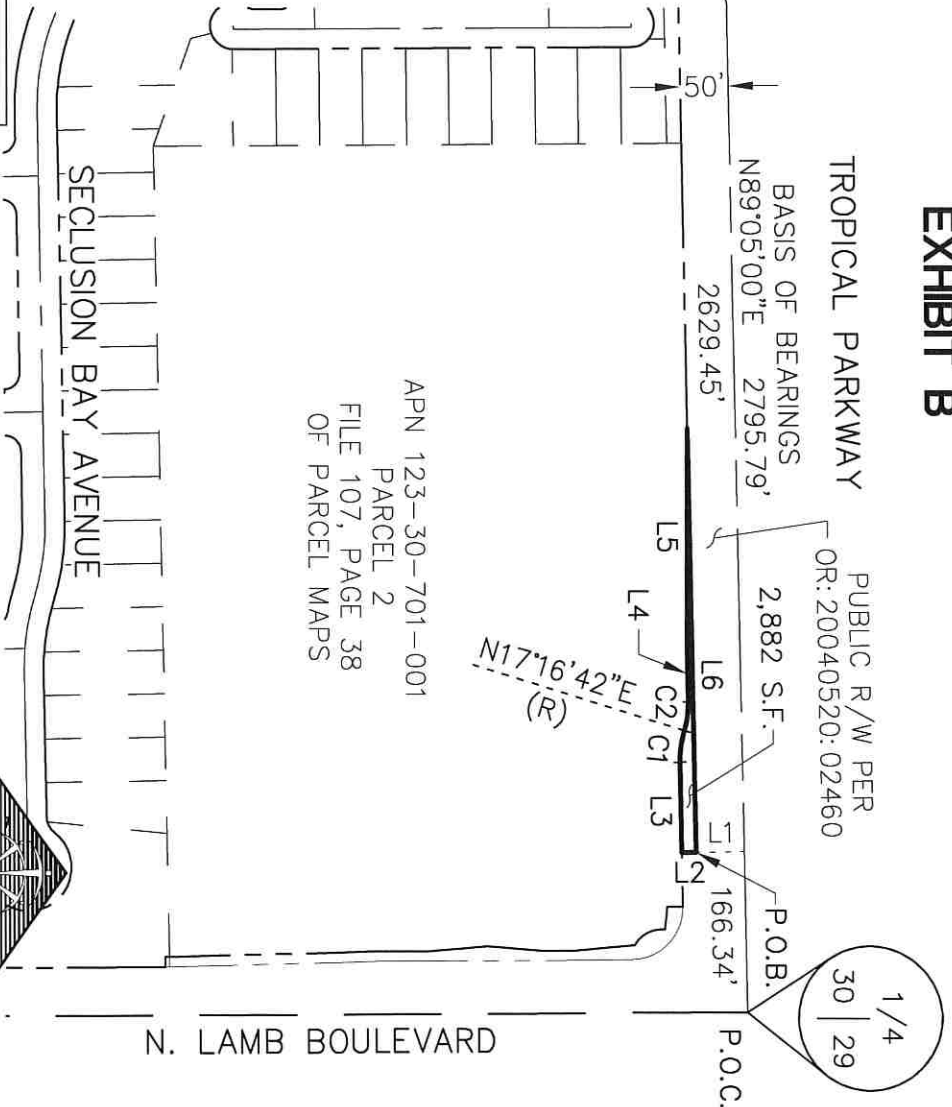
