BACKGROUND:

The Regional Transportation Commission of Southern Nevada (RTC) Freeway and Arterial System of Transportation (FAST) staff requests approval and authorization of the Interlocal Contract for local match funding for the Advanced Transportation and Congestion Management Technologies Deployment (ATCMTD) US-95 Integrated Safety Technology Corridor project. The project scope is to design, construct, operate, and evaluate various safety technologies along US-95, between Interstate-15 and Summerlin Parkway for the period from the date of grant issuance through December 31, 2024. The non-federal share allocated to the local public agencies is \$9,000,000.00. The RTC non-federal share is \$3,068,701.00. This Interlocal Contract will allocate and approve funding for the RTC non-federal share. Staff recommends approval.

**INTERLOCAL CONTRACT
ADVANCED TRANSPORTATION AND CONGESTION MANAGEMENT
TECHNOLOGIES DEPLOYMENT
US-95 PROJECT INTEGRATED SAFETY TECHNOLOGY CORRIDOR**

THIS INTERLOCAL CONTRACT is made and entered into this 12TH day of August 2021, by and between Clark County, a political subdivision; the City of Las Vegas, a municipal corporation; the City of North Las Vegas, a municipal corporation; the City of Henderson, a municipal corporation; the City of Boulder City, a municipal corporation; and the City of Mesquite, a municipal corporation; hereinafter referred to individually as “ENTITY” or collectively as “ENTITIES,” and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as “RTC.” The RTC and the ENTITIES are hereinafter referred to individually as “PARTY” or collectively as “PARTIES.”

W I T N E S S E T H

WHEREAS, the RTC, in coordination with the ENTITIES, intends design, construct, operate, and evaluate various safety technologies along US-95 between I-515 and Summerlin Parkway, which is included on the adopted RTC Capital Improvement Plan, hereinafter referred to as “PROJECT,” located wholly within Clark County, City of Las Vegas, City of North Las Vegas, City of Henderson, City of Boulder City; and City of Mesquite, and

WHEREAS, Nevada Revised Statute (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

WHEREAS, the ENTITIES agrees to conform to the current RTC Policies and Procedures, as amended and incorporated herein by reference; and

WHEREAS, the RTC has entered into Agreement #21-061 with the Federal Highway Administration (FHA) and Nevada Department Transportation (NDOT); and

WHEREAS, the RTC has entered into Agreement # P293-21-063 with the NDOT; and

WHEREAS, the RTC’s financial obligation from said agreements with FHA and NDOT will be covered by this Interlocal Contract; and

WHEREAS, the RTC will be the lead agency for the PROJECT; and

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the Parties hereto, the Parties agree to proceed as follows:

SECTION I: SCOPE OF PROJECT

This Interlocal Contract applies to design, construct, operate, and evaluate various safety technologies along US-95 between I-515 and Summerlin Parkway. The Project is further described in Exhibit “A” which is attached hereto and by this reference incorporated herein.

SECTION II: PROJECT COSTS

The RTC agrees to provide funding for all costs associated with the PROJECT from the Highway Improvement Acquisition Fund as outlined below:

1. The total cost for this contract shall not exceed \$3,100,000.00.
2. Authorizations to Proceed (ATP) are granted as follows:
 - a. ENGINEERING not to exceed \$3,100,000.00
 - b. RIGHT-OF-WAY not to exceed \$0.00
 - c. CONSTRUCTION not to exceed \$0.00
3. At the time the ATP for construction is granted, the ENTITIES will make all attempts to publish the bid for this PROJECT within 90 calendar days.
4. A supplemental interlocal contract will be required for any changes to the amounts identified in number 2 above.

SECTION III: GENERAL

1. It is understood and agreed that the purpose of this Interlocal Contract is to fund the PROJECT as herein above set forth. It is further understood and agreed that the RTC is responsible for the design of the PROJECT. The RTC will be responsible for the actions or inactions of its Officers and Employees.
2. The PROJECT must be completed to the satisfaction of the RTC prior to the current applicable completion date of December 31, 2026. The RTC may, at any time thereafter, grant time extensions or terminate this Contract.
3. The RTC disavows any responsibility for the actions or inactions of the ENTITIES, their Officers, Employees, or agents.


