

**AMENDMENT NO. 1
TO THE
ON-CALL PROFESSIONAL COATING INSPECTION SERVICES AGREEMENT**

This Amendment No. 1, made and entered into effective the ____ day of _____, 2025 by and between the City of North Las Vegas, Nevada, a Nevada municipal corporation (hereinafter referred to as "City"), and Industrial Inspection Group, Inc. an Arizona Corporation, (hereinafter referred to as "Consultant") modifies the On-Call Professional Coating Inspection Services Agreement, herein after "Agreement for the fees as hereinafter described.

W I T N E S S E T H:

Whereas, on April 9, 2024, the City and Consultant entered into an Agreement for on-call coating inspections; and

Whereas, the City and Consultant desire to amend the Agreement to revise the contract to include Supplemental Services in a not-to-exceed amount of Fifty-Four Thousand Dollars and 00/100 (\$54,000) to perform fulltime coating inspections for the Apex Elevated Tank Project;

Whereas, the City and Consultant desire to delete the original Industrial Inspection Group, Inc. proposal dated April 2, 2024 in its entirety and replace it with the revised Industrial Inspection Group, Inc. proposal Dated December 10, 2024 attached as Exhibit "A".

Now, therefore, in consideration of the promises and terms contained herein, the parties agree to amend the Agreement as follows:

1. Section VIII, "Compensation and Terms of Payment", Subsection A, "Total Compensation", shall be deleted in its entirety and replaced with the following:

A. TOTAL COMPENSATION

1. The City shall pay the Consultant an amount for each of the tasks described in Exhibit "A":

2. Exhibit "A" of the Agreement dated April 2, 2024 is hereby deleted in its entirety and replaced with the attached revised Exhibit "A" dated December 10, 2024
3. The remainder of Agreement shall remain unchanged.
