**Brief Description of Collection Development Project:**

We will be building a collection of Wonderbook Phonics and Decodables, a new product from Playaway. In Phonics mode, listeners have the opportunity to sound out key phonemes and graphemes from the text alongside their instructor. Kids can proudly level up their skills with books ranging from PreK-4 / Lexile levels 40L to 850L.

**Describe the need for the materials and how the need was determined:**

These new Wonderbooks are in-line with our school ready and read by grade 3 initiatives. Students will have the ability to simply listen and read along with one of the books, or they can switch to Phonics mode to have the opportunity to practice applying their knowledge of letter-sound relationships to independently recognize words.

**Types of materials to be purchased:**

We will be purchasing a collection of the new Wonderbook Phonics and Decodables from Playaway for each of our 3 library branches, along with some additional Wonderbook 5-Level Guided Reading System titles.
