3. Discussion of 2023 Activities Conducted by the Veterans Resource Center. (For Discussion)

Veterans Service coordinator Walter Lescano provided updates of the activities of the Center in 2023 stating that as of December 2023, 776 veterans and their families in the area of mental health and wellness, housing, employment, education, finance and legal received services. From those services provided, 104 were workshops. In addition, we held 34 peer support groups and six events that included the operation Family Christmas, Veterans Day Parade Center's Anniversary Block Party, Memorial Day Barbecue, job fairs, and Resource Fair.

Members commended **Mr. Lescano** and staff for the work that they have done on behalf of the veterans in the area.

Chairman Kelly reported on the several past and upcoming events including: Women's event in March, Children's event in April, Resource Fair Block Party during the summer, Hispanic event for September, Turkey Drive for November, GI Operation Christmas Family for December, and Veteran Parade for November. There was a consensus to conduct additional research on the events discussed before setting them on the calendar.

She is also the President of Nevada Women and Trades, and the first African-American woman to obtain a plumber's license in the State of Nevada. She spoke of the availability of resources for veterans to receive job and skill training to prepare them for careers in the trade fields. She invited the Commission to attend the American Legion Post on March 30th from 11 a.m. to 3 p.m. for a community event, and March 9th they are hosting the Women's Veterans Conference at the Aliante Resort, from 9 a.m. to 3 p.m.

Christina Costanzo, 3305 N. Rome Blvd, #1131 N. Las Vegas, NV 89086 stated this is her first time attending the meeting, and that she moved to town to be close to the Veterans Center. She appreciates the work that **Mr. Lescano** does and is grateful that there is a center that supports veterans.
