**STAFF COMMENTS AND BACKGROUND INFORMATION:**

The Southern Nevada Water Authority (SNWA) desires to construct the Garnet Valley Wastewater System within the City’s jurisdictional boundaries along Grand Valley Parkway and US 93 corridors.

The City desires to oversize the water transmission improvement, Grand Valley 2420/2295 PZ Waterline (Segment A), as part of SNWA’s Garnet Valley Wastewater System.

The City desires to install two water transmission line extensions, Grand Valley 2420/2295 PZ Waterline (Segment B) and Mountain View 2545 PZ Waterline (Segment C), as part of SNWA’s Garnet Valley Wastewater System.

Combining construction efforts will have numerous benefits, including shared infrastructure costs between the Parties, minimal time of disturbance for local residents and businesses, and minimization of construction conflicts that would occur if multiple contracts were administered concurrently.

The cost to oversize Segment A and to install the two water transmission line extensions for Segment B and Segment C is \$29,069,638 with SNWA’s portion of the cost to be \$4,145,927 and the City’s portion of the cost to be \$24,923,711.
