SUBJECT: Second Amendment to Citywide Security Services Agreement with American Guard Services, Inc. to Add Additional Security Personnel at City Hall and Flood Channels and to Increase the Not to Exceed Amount by \$220,738.24 for the Three Year Term of the Agreement (from \$4,044,973.80 to \$4,265,712.04) and Authorization for City Manager to Approve Future Amendments to the Citywide Security Services Agreement in Amounts Not to Exceed \$100,000 in Additional Funding. RECOMMENDATION OR RECOMMEND MOTION: Approve the Second Amendment to Citywide Security Services Agreement and authorize City Manager or her designee to approve future amendments to Citywide Security Services Agreement in amounts not to exceed \$100,000 in additional funding.

STAFF COMMENTS AND BACKGROUND INFORMATION:

The City of North Las Vegas entered into the Citywide Security Services Agreement (Original Agreement) with American Guard Services, Inc. (Provider) on November 28, 2022. The Original Agreement was amended on January 9, 2023 to modify the background check provision of the Original Agreement. The Provider’s security officers play a vital role in ensuring the safety of citizens utilizing our parks and facilities and contributing to the City’s priority of being a safe and livable community. Contracted security officers also provide customer service, report potential maintenance issues, secure City parks, facilities and bathrooms after hours, and document any potential issues or concerns. Without these services, it would be difficult for City staff to

maintain the same level of customer service and park/facility conditions, as many items and issues would go unreported.

This amendment adds additional security officer patrols at Regional Flood Control District facilities in the City and adds an additional security officer at City Hall. The increase in security officers and patrols will increase the amount due the Provider under the Original Agreement by \$220,738.24 for the remainder of the Original Agreement's term. Additionally, City staff is requesting that City Council authorize the City Manager to approve any additional amendments to the Original Agreement that would increase funding for this agreement in an amount not to exceed \$100,000.
