**STAFF COMMENTS AND BACKGROUND INFORMATION:**

The City of North Las Vegas has developed its Five-Year Housing & Urban Development (HUD) Consolidated Plan as a direct Entitlement Community for Community Development Block Grant (CDBG) and Emergency Solutions Grant (ESG) funds. The purpose of this Annual Action Plan is to identify the City's housing and community development needs, priorities, goals, and strategies and to stipulate how funds will be expended towards housing and community development activities during the 2024/2025 program year.

The draft plan was available for public review and comment from April 1 - April 30, 2024 on the City's website at the following url: <https://www.cityofnorthlasvegas.com/business/land-development/housing-neighborhood-services>.

A public hearing was held on April 15, 2024 at the City of North Las Vegas City Hall Conference Room 111 to allow for public comments on the plan(s).

The public comments received during the public hearing and the public comment period are included in the

final version of the Consolidated Plan and Action Plan. The final plans also include the HUD approved dollar amounts for the 2024 CDBG and ESG allocations. Once approved by City Council, both the Consolidated Plan and Action Plan must be submitted to HUD for review and final approval. The Annual Action Plan will be submitted to HUD 45 days before the start of the program year or less than 60 days after the date HUD announces FY 2024 allocation of CDBG and ESG funding.

The final 2024 Action Plan was made available after the public comment period ending April 30, 2024.
