STAFF COMMENTS AND BACKGROUND INFORMATION:

This Supplemental Interlocal Contract No. 5 (1321) has recently been approved by the Regional Transportation Commission of Southern Nevada (RTC).

The cities of Las Vegas, Henderson, Boulder City, North Las Vegas, and Mesquite, Clark County and RTC partnered for the funding of RTC – Traffic Signal Maintenance Project. The RTC will be the lead agency on this project. The RTC serves as both the financial and physical lead agency for this project.

On January 4, 2023 Council approved the multi-jurisdictional Interlocal Contract for the RTC –Traffic Signal Maintenance Project. This project provides construction funding for RTC’s current contract with Las Vegas Electric to respond to emergency calls including the necessary prompt temporary and/or permanent repair for RTC member agencies.

On July 14, 2022 Council approved Supplemental Interlocal Contract No. 1 which increased funds and extended the contract completion date.

On November 16, 2022 Council approved Supplemental Interlocal Contract No. 2 which re-delegated funds for this project from the category of engineering to construction. The funds had been erroneously delegated in the previous contracts for this project.

On June 7, 2023 Council approved Supplemental Interlocal Contract No. 3 which provided additional construction funds for contractor services to provide emergency or on-call intelligent transportation Systems (ITS) infrastructure repairs and reimbursing the entities for ITS work that is not associated with a project.

On February 7, 2024 Council approved Supplemental Interlocal Contract No. 4 to reduce the funding of the

project due to scope changes.

Supplemental Interlocal Contract No. 5 will increase funds to continue this program.

This project is funded and administered by the RTC.
