Dear Andrew Moore:

Thank you for applying for the Services-Training-Officers-Prosecutors (STOP) and Sexual Assault Services Provider (SASP) grants for January 1, 2025, through December 31, 2025. This year, we received 45 applications, totaling \$3,618,827. The funding available for calendar year 2025 is approximately \$1,690,072 in STOP and \$811,564 in SASP for a total amount of \$2,501,636,

As explained during the pre-application meetings, a neutral and objective review team from multiple agencies reads, reviews, and evaluates each application. After evaluating the applications, the objective review team makes funding recommendations based on the following factors:

1. Adherence to the Notice of Funding Opportunity;
2. Compliance with Federal Purpose Areas;
3. Fit under State Priorities;
4. Adherence to the state's mandated STOP Implementation Plan;
5. Whether or not proposed activities are allowable;
6. Reasonableness of the amount requested;
7. The location of the agency and whether other services are available; and
8. Current compliance and achievement of goals and objectives if an agency is currently funded.

Below are comments from the review team on your application:

Area(s) for most opportunity for improvement	The tactic to improve care to victims seems too narrowly focused.

Although STOP and SASP grants are used to provide needed services, due to the limited funding available, the STOP and SASP grants are not able to fund every project at the funding level requested. Accordingly, we would like to offer your agency a STOP subaward for \$ 70,182. As stated in our Notice of Funding Opportunity, funding is contingent on available Federal funding and award levels may be increased or decreased during the course of the year.
