25. Presentation Regarding Legislative History of Nevada's Consolidated Tax. (Citywide)
(For Discussion)

Acting City Attorney Andy Moore provided context as to why he was making the power point presentation and spoke of the presentation made by Chairman Melvin King of the Charter Committee on August 21, 2024. Acting City Attorney spoke of the history of the C-Tax legislative history. He explained that C-Tax was formulated in 1997 via SB 254. C-Tax formula combined the distribution of six different tax types into one monthly distribution from the State of Nevada, as follows:

- Cigarette Tax
- Liquor Tax
- Government Services Tax (i.e. vehicle registration)
- Real Property Transfer Tax
- Basic City County Relief Tax (BCCRT)
- Supplemental City County Relief Tax (SCCRT)

Mr. Moore further explained the intent of C-Tax and said that it is a formula used to equitably distribute local government revenues first among Nevada's counties (and Carson City) and then among the 150+ political subdivisions within those counties. He said that after two years, Nevada legislators realized C-Tax formula benefited some local governments more than others. Mr. Moore explained that the C-Tax disparity continues to grow as noted in the City Council presentation on August 21, 2024. He said that North Las Vegas Library does not receive any funding from C-Tax.
