**EXPLANATION:** THIS DESCRIPTION REPRESENTS PORTIONS OF PUBLIC UTILITY AND PEDESTRIAN ACCESS EASEMENTS BEING VACATED IN SUPPORT OF THE "VTS VILLAGE 2" PROJECT.

**DESCRIPTION**

THAT PORTION OF THE PUBLIC UTILITY AND PEDESTRIAN ACCESS EASEMENTS GRANTED OVER CE2.07 OF "VTS VILLAGE 2" AS SHOWN BY MAP THEREOF IN BOOK 158, PAGE 33 OF PLATS IN THE CLARK COUNTY RECORDER'S OFFICE, NEVADA, LYING WITHIN GOVERNMENT LOTS 35 AND 36 OF SECTION 15, TOWNSHIP 19 SOUTH, RANGE 61 EAST, M.D.M., CITY OF NORTH LAS VEGAS, CLARK COUNTY, NEVADA, DESCRIBED AS FOLLOWS:

**BEGINNING** AT THE MOST NORTHERLY CORNER OF SAID CE2.07;

THENCE ALONG THE NORTHERLY AND EASTERLY LINES OF SAID CE2.07, THE FOLLOWING EIGHT (8) COURSES:

- 1) SOUTH 79°49'41" EAST, 23.69 FEET;
- 2) THENCE SOUTH 19°44'06" WEST, 20.35 FEET;
- 3) THENCE CURVING TO THE LEFT ALONG AN ARC HAVING A RADIUS OF 25.00 FEET, CONCAVE EASTERLY, THROUGH A CENTRAL ANGLE OF 09°27'44", AN ARC LENGTH OF 4.13 FEET;
- 4) THENCE SOUTH 10°16'22" WEST, 80.00 FEET;
- 5) THENCE CURVING TO THE LEFT ALONG AN ARC HAVING A RADIUS OF 25.00 FEET, CONCAVE EASTERLY, THROUGH A CENTRAL ANGLE OF 14°02'10", AN ARC LENGTH OF 6.12 FEET;
- 6) THENCE SOUTH 03°45'49" EAST, 35.08 FEET;
- 7) THENCE CURVING TO THE RIGHT ALONG AN ARC HAVING A RADIUS OF 25.00 FEET, CONCAVE WESTERLY, THROUGH A CENTRAL ANGLE OF 14°02'10", AN ARC LENGTH OF 6.12 FEET;
- 8) THENCE SOUTH 10°16'22" WEST, 722.52 FEET;

THENCE DEPARTING THE EASTERLY LINE OF SAID OF SAID CE2.07, NORTH 79°43'38" WEST, 30.00 FEET TO A POINT ON THE WESTERLY LINE OF SAID CE2.07;

THENCE ALONG THE WESTERLY LINE OF SAID CE2.07, NORTH 10°16'22" EAST, 872.81 FEET TO THE **POINT OF BEGINNING**.






