STAFF COMMENTS AND BACKGROUND INFORMATION:

Commerce Street, Henderson Circle to Craig Road improvements consist of removal and replacement of damaged and failing curb, gutter, sidewalk and asphalt pavement, restriping the entire roadway, upgrading to LED streetlights, utility relocations, and other appurtenances as may be necessary to construct a complete and functional project. (CIP No. 10280B-21)

Commerce Street Streetlight improvements consist of roadway lighting between Lone Mountain Road and the Lower Las Vegas Wash Trail on the west side of Commerce Street. The existing roadway is fully developed with the exception of the streetlights on the west side. The additional streetlights will improve visibility and safety. (CIP Project No. 10544)

The two projects were combined for the bid phase and five bids were received at the public bid opening held on October 2, 2023, as detailed on the attached Bid Abstract. The lowest responsive bid was submitted by Unicon, LLC, who is properly licensed and qualified to perform the work.

The project is required to be completed within 240 calendar days following the issuance of the Notice-to-Proceed.
