### EXPLANATION:

THIS LEGAL DESCRIBES A PORTION OF A PUBLIC UTILITY EASEMENT TO BE VACATED.

A PORTION OF THE 5-FOOT-WIDE PUBLIC UTILITY EASEMENT SHOWN ON AND GRANTED BY FILE 109, PAGE 72 OF PARCEL MAPS, ON FILE AT THE OFFICE OF THE COUNTY RECORDER, CLARK COUNTY, NEVADA AND LYING WITHIN THE NORTHWEST QUARTER (NW 1/4) OF THE SOUTHWEST QUARTER (SW 1/4) OF SECTION 36, TOWNSHIP 19 SOUTH, RANGE 61 EAST, M.D.M., CITY OF NORTH LAS VEGAS, CLARK COUNTY, NEVADA, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

**COMMENCING** AT THE NORTHWEST CORNER OF THE NORTHWEST QUARTER (NW 1/4) OF THE SOUTHWEST QUARTER (SW 1/4) OF SAID SECTION 36, BEING THE CENTERLINE INTERSECTION OF WASHBURN ROAD AND LOSEE ROAD; THENCE ALONG THE WEST LINE OF THE NORTHWEST QUARTER (NW 1/4) OF THE SOUTHWEST QUARTER (SW 1/4) OF SAID SECTION 36 AND THE CENTERLINE OF SAID LOSEE ROAD, SOUTH 00°46'30" EAST, A DISTANCE OF 339.39 FEET; THENCE DEPARTING SAID SECTION LINE AND STREET CENTERLINE, NORTH 89°13'30" EAST, A DISTANCE OF 59.85 FEET TO THE EASTERLY RIGHT-OF-WAY OF SAID LOSEE ROAD, BEING THE **POINT OF BEGINNING**; THENCE NORTH 00°29'53" EAST, A DISTANCE OF 8.66 FEET TO THE BEGINNING OF A NON-TANGENT CURVE, CONCAVE TO THE NORTHEAST, HAVING A RADIUS OF 5.00 FEET, FROM WHICH BEGINNING THE RADIUS POINT BEARS SOUTH 89°29'14" EAST; THENCE SOUTHEASTERLY ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 90°01'45", AN ARC LENGTH OF 7.85 FEET TO A POINT OF TANGENCY; THENCE SOUTH 89°31'00" EAST, A DISTANCE OF 5.00 FEET; THENCE SOUTH 00°29'53" WEST, A DISTANCE OF 22.69 FEET; THENCE NORTH 89°13'30" EAST, A DISTANCE OF 10.00 FEET; THENCE SOUTH 00°29'53" WEST, A DISTANCE OF 33.53 FEET; THENCE NORTH 89°30'05" WEST, A DISTANCE OF 5.00 FEET TO THE BEGINNING OF A TANGENT CURVE, CONCAVE TO THE SOUTHEAST, HAVING A RADIUS OF 15.00 FEET; THENCE SOUTHWESTERLY ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 90°00'02", AN ARC LENGTH OF 23.56 FEET TO A POINT OF NON-TANGENCY, TO WHICH A RADIAL LINE BEARS NORTH 89°30'07" WEST; THENCE NORTH 00°29'53" EAST, A DISTANCE OF 13.23 FEET TO THE BEGINNING OF A NON-TANGENT CURVE, CONCAVE TO THE SOUTHEAST, HAVING A RADIUS OF 20.00 FEET, FROM WHICH BEGINNING THE RADIUS POINT BEARS SOUTH 48°05'33" EAST; THENCE NORTHEASTERLY ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 48°35'26", AN ARC LENGTH OF 16.96 FEET TO A POINT OF NON-TANGENCY, TO WHICH A RADIAL LINE BEARS NORTH 00°29'53" EAST; THENCE NORTH 00°29'53" EAST, A DISTANCE OF 23.42 FEET; THENCE SOUTH 89°13'30" WEST, A DISTANCE OF 10.00 FEET; THENCE NORTH 00°29'53" EAST, A DISTANCE OF 22.80 FEET TO THE BEGINNING OF A NON-TANGENT CURVE, CONCAVE TO THE NORTHEAST, HAVING A RADIUS OF 10.00 FEET, FROM WHICH BEGINNING THE RADIUS POINT BEARS NORTH 00°29'53" EAST; THENCE NORTHWESTERLY ALONG SAID CURVE, THROUGH A CENTRAL ANGLE OF 30°00'00", AN ARC LENGTH OF 5.24 FEET TO A POINT OF NON-TANGENCY TO WHICH A RADIAL LINE BEARS SOUTH 30°29'53" WEST, BEING THE **POINT OF BEGINNING**;

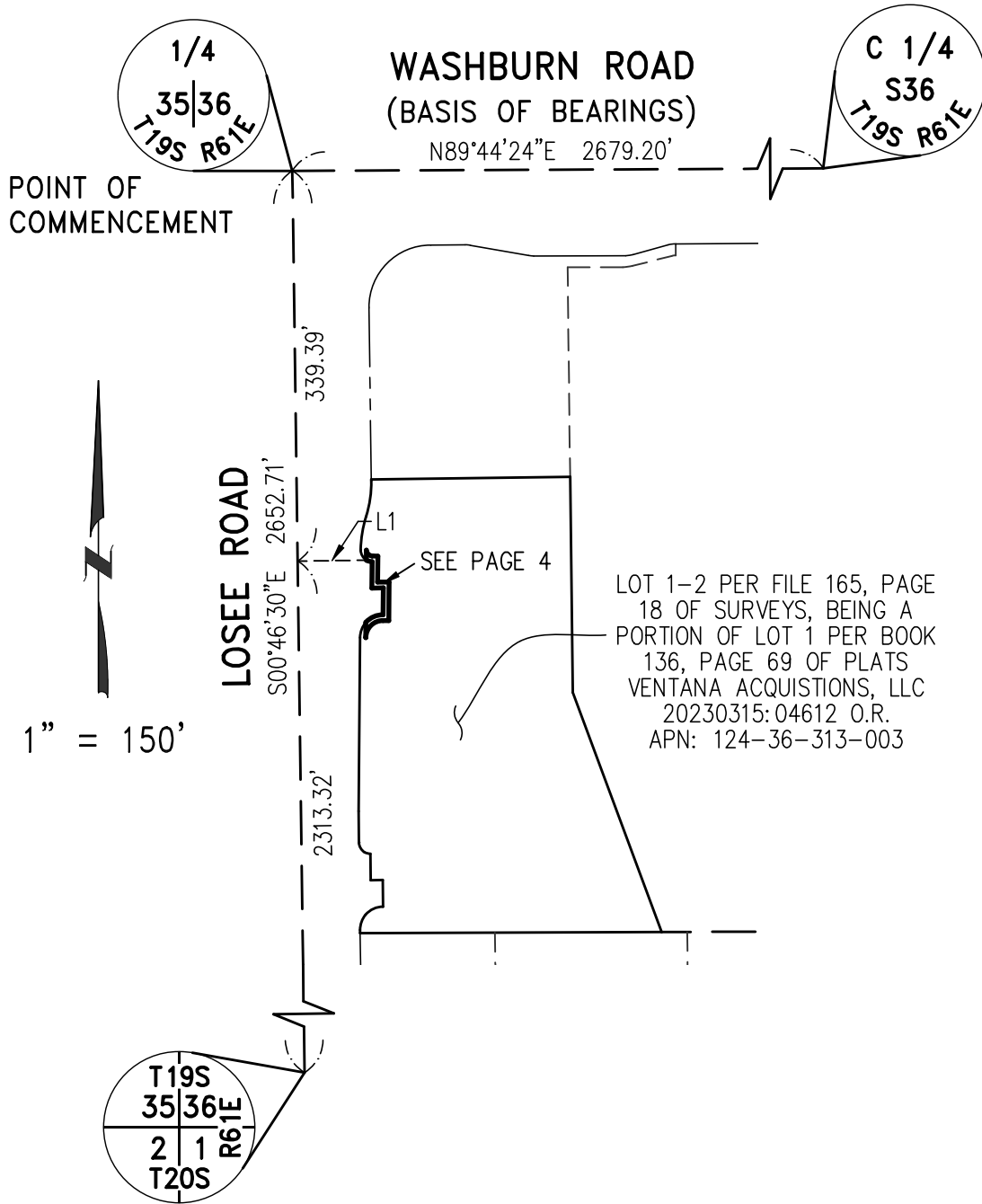

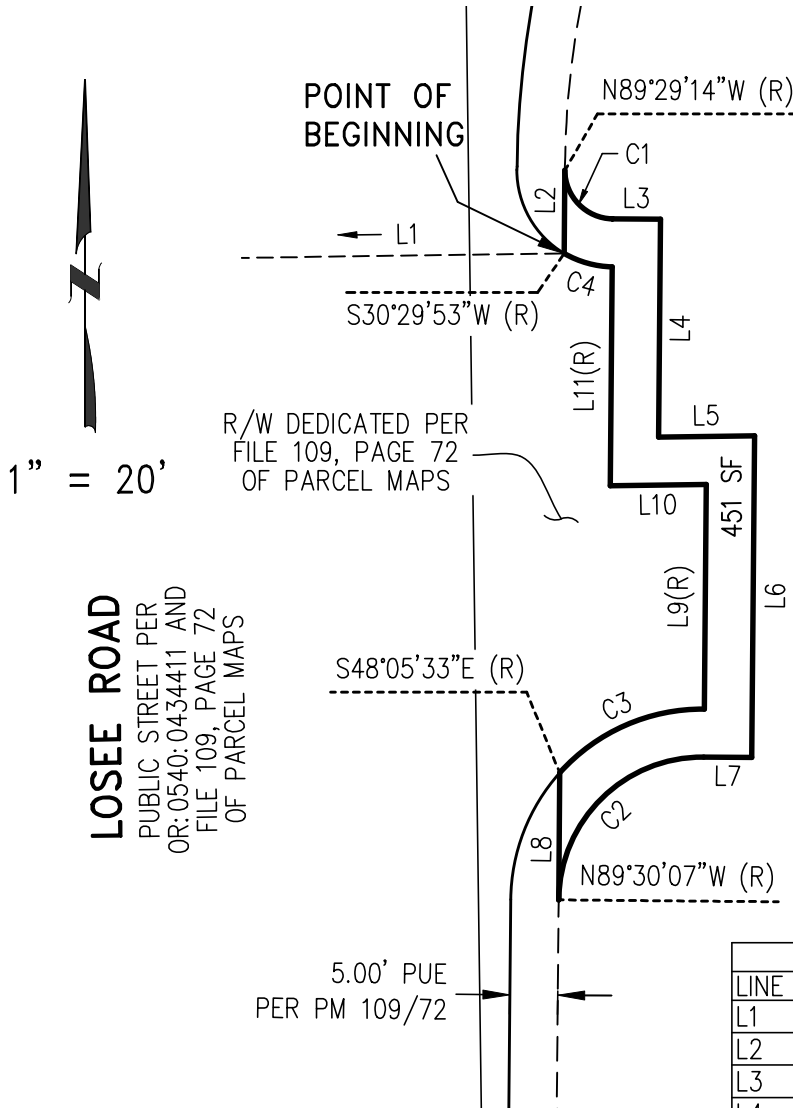
