STAFF COMMENTS AND BACKGROUND INFORMATION:

This Agreement for Communications Equipment and Services with Motorola Solutions, Inc. (Equipment Agreement) is part of the City's upgrade to its 911 system. At its meeting on October 2, 2024, City Council approved the Vesta Hosted Service Portfolio Motorola Services Agreement with Motorola Solutions Connectivity, Inc. The Equipment Agreement involves the purchase of phones and other hardware necessary to upgrade the City's 911 system to Vesta. The current equipment has reached its end of life. The agreement approved at the October 2, 2024 pertained to the services and support necessary to operate the upgraded 911 system.

This agreement is exempt from competitive bidding pursuant to NRS 332.115(1)(s), for the design of, and equipment and services associated with systems of communication.
