EXPLANATION: THIS DESCRIPTION REPRESENTS PORTIONS OF PUBLIC UTILITY AND PEDESTRIAN ACCESS EASEMENTS BEING VACATED IN SUPPORT OF THE "VTS VILLAGE 2" PROJECT.

DESCRIPTION

THAT PORTION OF THE PUBLIC UTILITY AND PEDESTRIAN ACCESS EASEMENTS GRANTED OVER CE2.08 OF "VTS VILLAGE 2" AS SHOWN BY MAP THEREOF IN BOOK 158, PAGE 33 OF PLATS IN THE CLARK COUNTY RECORDER'S OFFICE, NEVADA, LYING WITHIN GOVERNMENT LOTS 35 AND 36 OF SECTION 15, TOWNSHIP 19 SOUTH, RANGE 61 EAST, M.D.M., CITY OF NORTH LAS VEGAS, CLARK COUNTY, NEVADA, DESCRIBED AS FOLLOWS:

BEGINNING AT THE MOST NORTHERLY CORNER OF SAID CE2.08;

THENCE ALONG THE NORTHERLY AND EASTERLY LINES OF SAID CE2.08, THE FOLLOWING THREE (3) COURSES:

- 1) SOUTH 79°49'41" EAST, 30.00 FEET;
- 2) THENCE SOUTH 10°16'22" WEST, 867.11 FEET;
- 3) THENCE CURVING TO THE LEFT ALONG AN ARC HAVING A RADIUS OF 1215.00 FEET, CONCAVE SOUTHEASTERLY, THROUGH A CENTRAL ANGLE OF 02°43'05", AN ARC LENGTH OF 57.64 FEET TO A POINT TO WHICH A RADIAL LINE BEARS NORTH 82°26'43" WEST;

THENCE DEPARTING THE EASTERLY LINE OF SAID OF SAID CE2.08, NORTH 82°26'43" WEST, 25.10 FEET TO A POINT ON THE WESTERLY LINE OF SAID CE2.08;

THENCE ALONG THE WESTERLY LINE OF SAID CE2.08, THE FOLLOWING THREE (3) COURSES:

- 1) FROM A POINT TO WHICH A RADIAL LINE BEARS NORTH 85°15'37" WEST, CURVING TO THE RIGHT ALONG AN ARC HAVING A RADIUS OF 1752.00 FEET, CONCAVE SOUTHEASTERLY, THROUGH A CENTRAL ANGLE OF 01°37'13", AN ARC LENGTH OF 49.55 FEET TO A POINT OF COMPOUND CURVATURE TO WHICH A RADIAL LINE BEARS NORTH 83°38'24" WEST;

2) THENCE CURVING TO THE RIGHT ALONG AN ARC HAVING A RADIUS OF 952.00 FEET, CONCAVE SOUTHEASTERLY, THROUGH A CENTRAL ANGLE OF 03°54'45", AN ARC LENGTH OF 65.01 FEET;

3) THENCE NORTH 10°16'22" EAST, 811.52 FEET TO THE **POINT OF BEGINNING**.

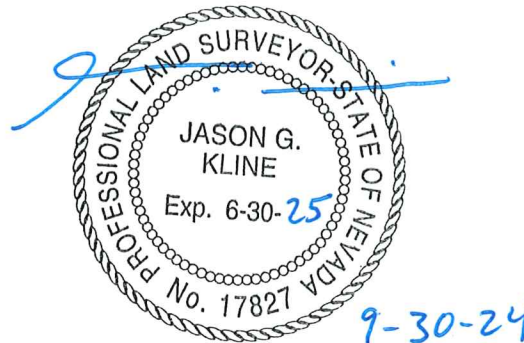

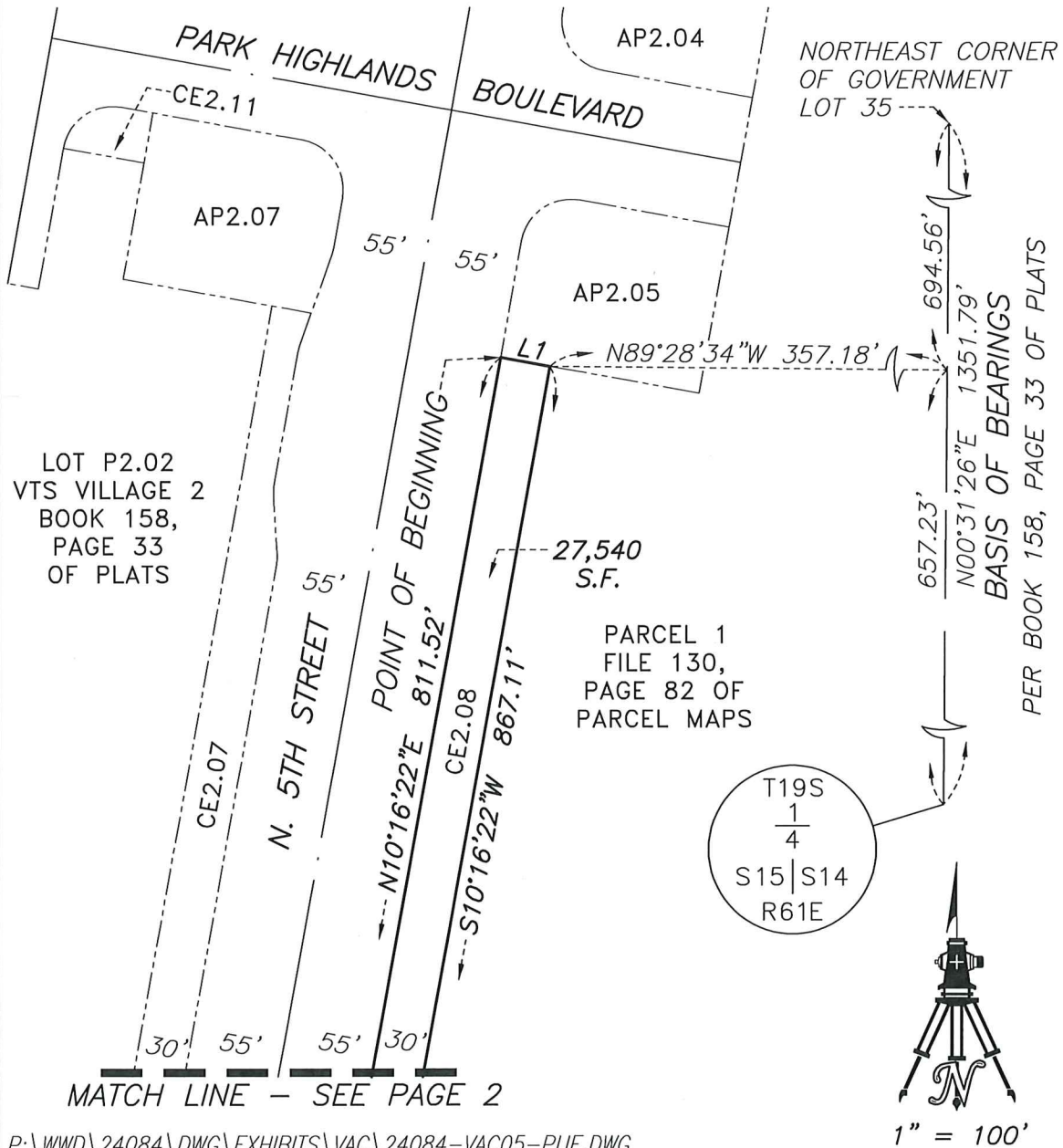

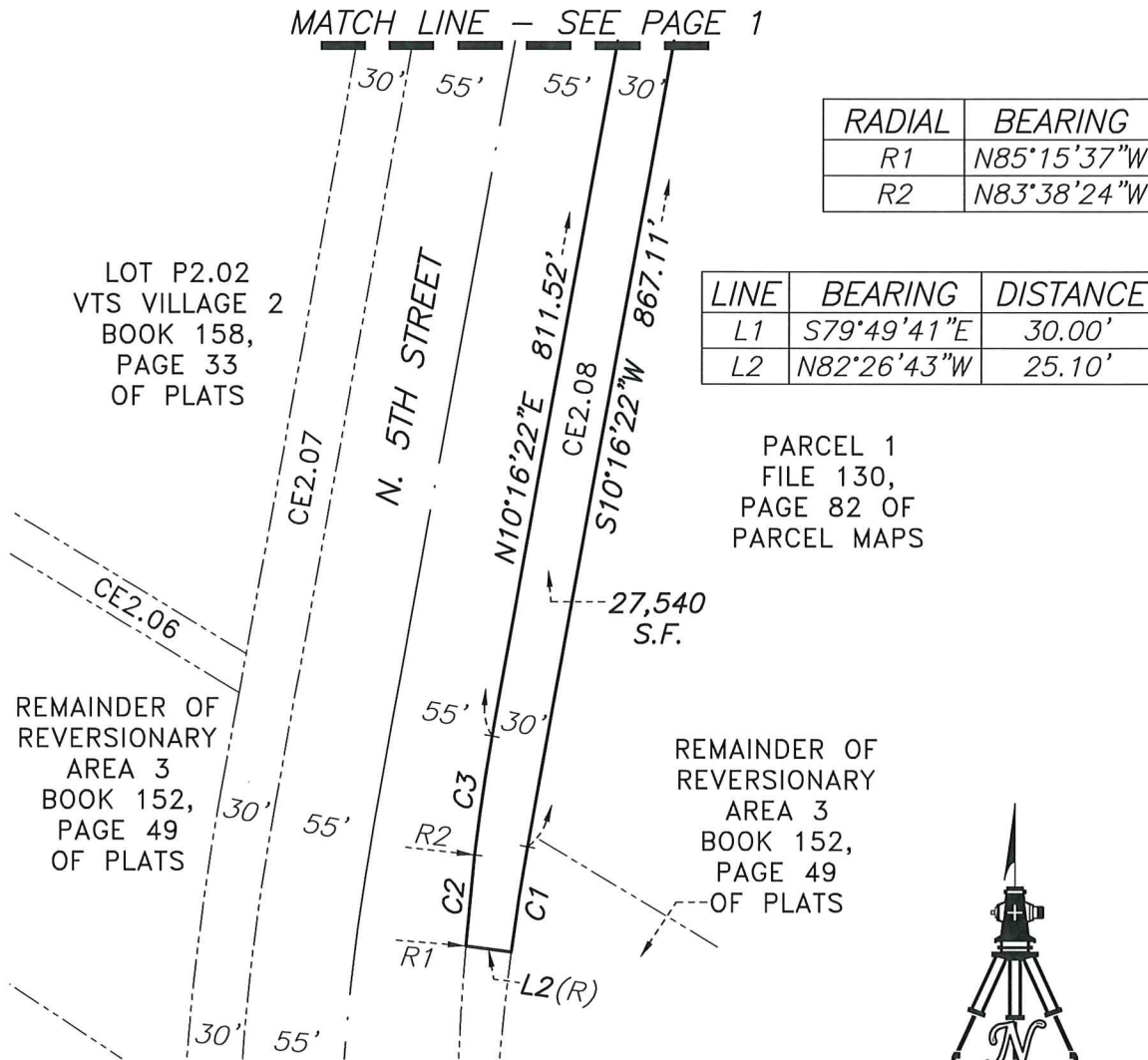
