The City of North Las Vegas has jointly participated with Clark County Nevada in the Community Development Block Grant (CDBG) program since 1982. On February 7, 2007, through Resolution No. 2370, the City Council approved the Interlocal Agreement, which authorizes the City to participate in the CDBG Urban County program for the period October 1, 2006 through September 30, 2009. The attached resolution No. 2399 authorizes the City to participate in the program for the period July 1, 2009 through June 30, 2012.

Staff recommends approval of Resolution No. 2399 and authorization for the Mayor to sign.



RESOLUTION NO. 2399

**A RESOLUTION OF THE CITY COUNCIL OF
THE CITY OF NORTH LAS VEGAS
ADOPTING INTERLOCAL AGREEMENT FOR THE
DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT
COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM**

WHEREAS, the CITY OF NORTH LAS VEGAS AND CLARK COUNTY, heretofore referred to as the CITY and the COUNTY respectively, desire to engage in housing and community development activities as authorized under the Housing and Community Development Act of 1974 and subsequent amendments; and

WHEREAS, it is necessary to enter into an Agreement in order to meet the requirements of the Housing and Community Development Act of 1974 and subsequent amendments; and

WHEREAS, the CITY AND COUNTY are public agencies under the provisions of Section 277.180 of the Nevada Revised Statutes, and each is authorized by law to enter into joint powers agreements; and

WHEREAS, the CITY AND COUNTY are individually authorized by law to engage in housing and community development activities; and

WHEREAS, the CITY and the COUNTY do hereby find and determine that it is in the best interest of the residents of the CITY and unincorporated areas of the COUNTY that housing and community development activities be performed jointly in accordance with the provisions of this Agreement; and

WHEREAS, it is mutually beneficial to each of the parties for the COUNTY to administer and execute the provisions of this agreement in accordance with the terms and conditions hereinafter provided and subject to local ordinance, state and federal law.

NOW THEREFORE, BE IT RESOLVED, that the City Council of the City of North Las Vegas hereby approves the Interlocal Agreement for the Housing and Urban Development Community Development Block Grant Urban County Program for the Period of July 1, 2009 through June 30, 2012.
