

Amendment No. 1 to
Cooperative Agreement No. PR395-11-063

This Amendment is made and entered into this 7TH day of AUGUST, 2015, between the State of Nevada, Department of Transportation, hereinafter referred to as the DEPARTMENT, and the City of North Las Vegas, 2250 North Las Vegas Blvd., Suite 610, North Las Vegas, NV 89030, hereinafter referred to as the CITY.

WITNESSETH:

WHEREAS, on September 13, 2011, the Parties entered into Agreement No. PR395-11-063 for the construction of the widening of North 5th Street from 1,000 feet south of Losee Rd. to Cheyenne Ave.; and

WHEREAS, the termination date is amended due to delays in the advertisement, construction and close out of the PROJECT; and

WHEREAS, the Parties hereto desire to make certain amendments to Agreement No. PR395-11-063.

NOW, THEREFORE, the Parties agree as follows:

- A. The termination date referenced in Article III Paragraph 1, shall be changed from December 31, 2015 to December 31, 2017.
- B. Article III, Paragraph 14, is amended by deleting it in its entirety and inserting in its place:
