RESULTS OF CANVASS OF THE PRIMARY ELECTION IN THE CITY OF NORTH LAS VEGAS JUNE 14, 2022

The results of the June 14, 2022 Primary Election were canvassed comparing the computer printout of ballots counted and the results thereof with the official ballot statements for the 78 precincts used in the election.

There were 15 irreconcilable errors in the 27,771 ballots cast in the 78 precincts. Eight were in the mail returns caused by voters who voted their initial ballot, then updated their voter registration prior to the May 31 deadline. Four extra votes were cast, 2 during early voting and 2 on Election Day. Three voters voted in the wrong precinct. However, there were no tabulation errors in the 78 precincts, and the foregoing irreconcilable discrepancies would not alter the outcome of any race in this Primary Election.

One hundred forty-four provisional ballots were cast during the election, 140 were verified and counted, 2 were rejected because the voters were not registered to vote, and 2 were rejected because the voter did not provide adequate proof of residence or identification.

Audits were performed according to 293B on the hash code of our ICX voting machines and the VVPAT rolls for 2% of all machines used in the election. No discrepancies were identified. The accuracy certification board also certified the functionality of our tabulation system, to include our mail readers, ICX voting machines, Agilis mail ballot processing machine, and tabulation system. All systems were found to be 100% accurate in the tabulation of votes and processing of mail ballots. The tests were performed before the start of early voting, the day before Election Day, and a post-election test the day after the election.

Therefore, as the duly appointed Registrar of Voters of Clark County, Nevada, I do hereby approve the canvassed results of the Primary Election for certification.
