AMENDMENT NO. 2

TO THE

PROFESSIONAL ENGINEERING SERVICES AGREEMENT FOR THE

FY19-21 CITYWIDE SCHOOL SAFETY IMPROVEMENTS

This Amendment No. 2, is made and entered into as of the _____ day of _____, 2023, by and between the City of North Las Vegas, a Nevada municipal corporation, (the "City"), and HDR Engineering, Inc., a Nebraska corporation, (hereinafter referred to as "Consultant"), amends the Professional Engineering Services Agreement, hereinafter referred to as "Agreement" for the FY 19-21 Citywide School Safety Improvements (hereinafter referred to as "Project"), for the services and fees as hereinafter described.

WITNESSETH:

Whereas, on December 5, 2018, the City and Consultant entered into the Agreement for the Project; and

Whereas, on May 1, 2019 the City and Consultant amended the Agreement with Amendment No. 1 to include design services for improvements to additional schools; and

Whereas, the City and Consultant desire to amend the Agreement with Amendment No. 2 to include additional design services for the Project, as set forth in Exhibit "A-3" "Scope of Supplemental Services #2".

Now, therefore, in consideration of the promises and terms contained herein, the parties agree to amend the Agreement as follows:

- 1) Section III "Scope of Services" shall be amended by adding Exhibit "A-3" "Scope of Supplemental Services #2" to include Task SS3.1 Additional Project Management Services, Task SS3.2 Additional Legal Descriptions and Exhibits, and Task SS3.3 Utility and Agency Coordination to the Scope of Services to be performed by Consultant under the Agreement. Exhibit "A-3" is attached hereto and made a part hereof by reference.
- 2) Section VIII Subsection A of the Agreement shall be deleted in its entirety and replaced with the following:

A. TOTAL COMPENSATION

1. The City shall pay the Consultant an amount for each of the tasks described in Exhibits "A-1," "A-2," and "A-3" as follows:

EXHIBIT "A-3" SCOPE OF SUPPLEMENTAL SERVICES #2

HDR Engineering, Inc. (Consultant) shall provide Supplemental Services consisting of the scope items listed below. Supplemental scope will be incorporated directly into the Final Submittal.

SS 3.1 ADDITIONAL PROJECT MANAGEMENT SERVICES

Consultant shall extend project management services for an additional twelve (12) months.

SS 3.2 ADDITIONAL LEGAL DESCRIPTIONS AND EXHIBITS

Consultant shall perform engineering services to provide legal descriptions and exhibits for PHI and PHII City Funded Bid Packages. Legal descriptions and exhibits will identify roadway easements for installing traffic devices. Breakdown of legal descriptions and exhibits to be provided are listed below.

- Ruby Duncan Elementary School
 - One (1) legal description and exhibit in area previously surveyed.
- John Tarten Elementary School
 - One (1) legal description and exhibit in area not previously surveyed.
- Mojave High School
 - o Three (3) legal descriptions and exhibits in areas not previously surveyed.
- Cheyenne High School & Priest Elementary School
 - Two (2) legal descriptions and exhibits in areas not previously surveyed.
- Canyon Springs High School
 - o One (1) legal description and exhibit in area not previously surveyed.
- Owens Avenue and Davis Place
 - One (1) legal description and exhibit in area not previously surveyed.
- Goynes Elementary School
 - Twelve (12) legal descriptions and exhibits in areas previously surveyed.

This amounts to a total of thirteen (13) legal descriptions and exhibits in areas previously surveyed and eight (8) in areas that were not previously surveyed.

SS 3.3 UTILITY & AGENCY COORDINATION

Consultant shall perform coordination with utility companies and local agencies to add a utility review submittal for PHI and PHII City Funded Bid Packages, respond to and incorporate utility agency comments, and obtain final signatures as needed from the following:

- Clark County Regional Flood Control District (CCRFCD)
- CenturyLink/Lumen
- Cox Communications
- NV Energy (Distribution)
- NV Energy (Transmission)
- Regional Transportation Commission (RTC)
- Southwest Gas Corporation

SS 3.5 DESIGN UPDATES

Consultant shall perform the design updates described below at the respective school sites listed below. The RRFB and School Flasher schedule will be updated accordingly.

- Somerset Academy Centennial Campus
 - Update GIS aerial and right-of-way line work to depict current conditions at time of this agreement on the north leg of Centennial Parkway and Commerce Street. Additionally, show the existing easement where school flasher is to be installed. Available Clark County GIS information will be used.
- John Tarten Elementary School
 - o Move one (1) school flasher into new easement.
- Mohave High School
 - Move one (1) school flasher behind the existing sidewalk into new easement.
- Cheyenne High School & Priest Elementary School
 - o Move one (1) school flasher into new easement.
- Canyon Springs High School
 - Update three (3) sheets to reflect the latest development and right-of-way dedication on the northeast corner of 5th Street and Alexander Road using Clark County GIS information that is available.
