

**ORDINANCE NO. 3187**

AN ORDINANCE OF THE NORTH LAS VEGAS CITY COUNCIL AMENDING ORDINANCE NO. 2861 BY DELETING SUBSECTION I OF SECTION 2.16.020 OF THE CITY OF NORTH LAS VEGAS MUNICIPAL CODE TO REMOVE THE PLANNING COMMISSION'S LIMITATION ON CITIZEN SERVICE PROVISION AND TO PROVIDE FOR OTHER MATTERS PROPERLY RELATED THERETO.

WHEREAS, Ordinance No. 2861 enacted by the North Las Vegas City Council on February 7, 2018 prohibited members of the Planning Commission from simultaneously serving on another City board, commission, or committee; and

WHEREAS, the City desires to remove the limitation of citizen service provision from Section 13.02.020 of the North Las Vegas Municipal Code (NLVMC) in order to allow members of the Planning Commission to serve on another City board, commission, or committee.

NOW, THEREFORE, the City Council of the City of North Las Vegas does ordain:

**SECTION 1:** Subsection (I) of Section 2.16.020 of the North Las Vegas Municipal Code shall be deleted in its entirety.

**SECTION 2:** NON-INFRINGEMENT OF RIGHTS. The North Las Vegas City Council has been informed by the City Attorney as to the constitutionality of this ordinance and based upon such information the City Council is adopting this ordinance in good faith with a reasonable belief that the actions taken by the City Council are not in violation of any rights, privileges, or immunities secured by the laws providing for equal rights of citizens or persons.

**SECTION 3:** SEVERABILITY. If any section, paragraph, clause, or provision of this Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall in no way affect the validity and enforceability of the remaining provisions of this Ordinance.

**SECTION 4:** EFFECTIVE DATE. This Ordinance shall become effective after its passage by the City Council, and after such passage by the City Council, publication once by title in a newspaper qualified pursuant to the provisions of Chapter 238 of NRS, as amended from time to time.
