**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 1
CIVIC CENTER DRIVE
CAREY AVENUE TO CHEYENNE AVENUE**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 1 is made and entered into this 20TH day of May, 2021, by and between the City of North Las Vegas, a municipal corporation, hereinafter referred to as "CITY" and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as "RTC."

W I T N E S S E T H

WHEREAS, the RTC approved Interlocal Contract #1134 dated October 10, 2019, for improvements Civic Center Drive, Carey Avenue to Cheyenne Avenue, hereinafter referred to as "PROJECT," located wholly within the City of North Las Vegas; and

WHEREAS, Nevada Revised Statue (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

WHEREAS, the CITY agrees to conform to the current Policies and Procedures, as amended, incorporated herein by reference; and

WHEREAS, the CITY wishes to increase total PROJECT funding; and

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the Parties hereto, the Parties agree to proceed as follows:

SECTION II: PROJECT COSTS, Paragraphs 1 and 2 shall be changed to read as follows:

1. The total cost for this contract shall not exceed \$885,000.00
2. Authorizations to Proceed (ATP) are granted as follows:
 - a. ENGINEERING not to exceed \$860,000.00
 - b. RIGHT-OF-WAY not to exceed \$25,000.00
 - c. CONSTRUCTION not to exceed \$0.00

The remainder of the interlocal contract #1134 dated October 10, 2019, shall remain unchanged.
