THENCE DEPARTING THE WESTERLY LINE OF THE SOUTHWEST QUARTER (SW1/4) OF SAID SECTION 15, SOUTH 88°12'30" EAST, 65.38 FEET TO THE **POINT OF BEGINNING**;

THENCE NORTH 46°26'52" EAST, 21.72 FEET;

THENCE SOUTH 43°33'08" EAST, 21.72 FEET;

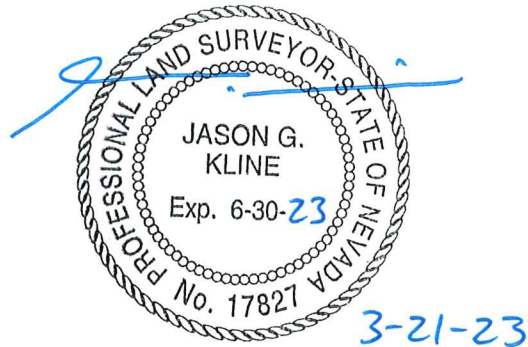
THENCE NORTH 88°33'08" WEST, 30.71 FEET TO THE **POINT OF BEGINNING**.

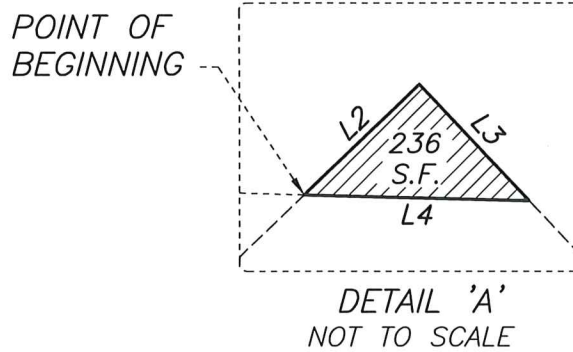
