Item 109.01 was set at a fixed for this project in the bid Proposal Packet, a Unit Price of \$25,000 and a Total Price of \$50,000, however, the Qty. was 1 LS. The price A. has been revised to reflect the intended Total Price of \$50,000.

B. Description "R920-E (solar) or equivalent", Bidder submitted a Total Price amount of \$29,085, the correct Total Price is \$87,255.

Bidder submitted a Total Base Bid of \$782,500, the corrected Total Base Bid (with the additional \$25,000 for Item 109.01) is \$807,500.

C. \*Even though note B indicates that the Total Price was incorrect, the Bidder added what the correct total should have been into the Total Base Bid. The bid submitted was correct, however that was before the correction to Item 109.01 was made, increasing the total Base Bid by \$25,000.

<sup>\*</sup>CG&B calculated a \$25,000 Total Price in the Total Base Bid, while Unicon calculated a \$50,000 Total Price in the Total Base Bid.
