

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 2
DOWNTOWN COMPLETE STREETS AND
PEDESTRIAN IMPROVEMENTS**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 2 is made and entered into this 14TH day of September 2023, by and between the City of North Las Vegas, a municipal corporation, hereinafter referred to as “CITY” and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as “RTC.” The CITY and RTC are collectively referred as the “PARTIES.”

W I T N E S S E T H

WHEREAS, the RTC approved Interlocal Contract 1174 dated March 12, 2020, and supplemental interlocal contract dated July 13, 2023, for improvements to Downtown Complete Streets and Pedestrian Improvements, hereinafter referred to as “PROJECT,” located wholly within City of North Las Vegas; and

WHEREAS, Nevada Revised Statutes (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

WHEREAS, the CITY agrees to conform to the current RTC Policies and Procedures, as amended and incorporated herein by reference; and

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the PARTIES hereto, the PARTIES agree to proceed as follows:

SECTION II: PROJECT COSTS; the first sentence shall be revised to read as follows:

The RTC agrees to provide funding for all costs associated with the PROJECT from the Highway Improvement Acquisition Fund – Motor Vehicle Fuel Tax Revenue.

The remainder of Interlocal Contract 1174 dated March 12, 2020, and supplemental interlocal contract dated July 13, 2023, shall remain unchanged.
