STAFF COMMENTS AND BACKGROUND INFORMATION:

On July 7, 2010, the City Council passed and adopted Ordinance No. 2551 which amended Section 13.02.010 of the North Las Vegas Municipal Code (NLVMC) by deleting language that prohibited the Sunrise Manor resident members of the Utility Advisory Board (UAB) from voting on wastewater-related matters heard by the UAB. The language in Section 1 of Ordinance No. 3179 amends NLVMC 13.02.010(a) to require that the Sunrise Manor resident members of the UAB reside at an address in the City's water service area. The current language allows Sunrise Manor residents who do not live at an address in the City's water service area to serve on the UAB.

On February 7, 2018, the City Council passed and adopted Ordinance No. 2862, which amended Section 13.02.020 of the North Las Vegas Municipal Code (NLVMC) pertaining to the terms of UAB members. Among other items, Section 1 of Ordinance No. 2862 added subsection (d) of NLVMC Section 13.02.020 which reads "Board members may not simultaneously serve on another City board, commission, or committee." Section 2 of Ordinance No. 3179 will delete subsection (d) of NLVMC 13.02.020 to allow UAB members to simultaneously serve on other City boards, commissions, or committees.
